## YOU MUST CHOOSE

If you currently have health care insurance coverage through the Office of Group Benefits, you will be required to select a new health insurance plan during the OGB Open Enrollment Period that begins on October 1, 2014 and ends on October 31, 2014. OGB is offering new health plans that will be implemented on January 1, 2015. Your current insurance plan will not be offered after December 31, 2014. It is imperative that you complete the Open Enrollment form that will be provided to you by OGB. If you fail to do so, OGB will automatically place you into the Pelican HRA 1000 plan, which may not be the best plan for you. (HRA stands for Health Reimbursement Account.)

Included in this issue is information that has been furnished to LRTA by OGB which provides a brief summary of plans to be offered. We also have included the OGB Open Enrollment meeting schedules. Note that one group of meetings is for active and retired

OGB members that are not eligible for Medicare, and the second group is specifically designed for those who currently have Medicare coverage. If you are eligible for Medicare, you should not attend a meeting for active and retired OGB members who do not have Medicare coverage.

You may have already received your Open Enrollment packet from OGB. Please pay attention to this important piece of mail, and remind your friends to open the mail and complete the form included in the envelope. If you plan on attending one of the Open Enrollment meetings, please take your plan booklet with you. The Open Enrollment form you will be completing must be mailed to the OGB office, and not to the employer from which you retired, as was done in the past. tration in January 2011. In April 2011, then-President Dr. James A. Taylor, Sr. appeared before the Senate Retirement Committee and publicly testified that the privatization of the Office of Group Benefits would eventually cause reductions in coverage and increases in premiums, or both. The association continued to register its opposition through public testimony at additional meetings held by the Senate Retirement Committee and the Senate Insurance Committee through the 2011 regular session of the Louisiana Legislature. When the contract with Blue Cross/Blue Shield for the administration of the program was presented by the Division of Administration to the Joint Legislative Committee on the Budget, then-President Dr. Lonnie E. Dunn, current President James T. Stewart, and LRTA Legislative Committee Chairman Benjamin L. Sandi-

## OGB Annual Enrollment for 2015 Health Care Benefits

There are 230,000 OGB members, and no two of them are alike. That's why OGB is offering an expanded list of health plan options for 2015. Whether you are looking for low (or even \$0) premiums, a large coverage network or predictable co-payments, OGB offers a plan that fit your needs. OGB's annual enrollment period is from October 1 through October 31. All members must select a plan during that time period. A summary of the plans is below, and we encourage you to attend one of the annual enrollment meetings across the state to learn more about the options available to you. Visit [groupbenefits.org](http://groupbenefits.org) for a schedule of meetings.

### OGB Medicare Advantage Plans

1) **OneExchange** - OneExchange offers the broadest range of individual Medicare coverage options for post-65 retirees, including Medigap (also known as Medicare Supplement), Medicare Advantage and Part D prescription drug plans. OneExchange has multiple plan offerings with well-known insurance carriers. Additionally, OneExchange offers a full range of enrollment support services and tools to aid you in evaluating which plan choice best meets your individual health care and financial needs. You will also be enrolled in a health reimbursement arrangement (HRA) receiving HRA credits of \$200 to \$300 per month from the state.

2) **Peoples Health Plan** - Peoples Health Medicare Advantage plans offer much more than Medicare, with extra benefits like vision and dental coverage, free health club membership and prescription drug coverage. As a Peoples Health Group Medicare member, you pay a premium in addition to paying your Medicare Part B premium; you receive 100 percent coverage for many services with NO Medicare deductibles. Peoples Health plans feature a member-centered model of care that offers coordinated, personalized service.

3) **Vantage Medicare Advantage** - For retirees who are 65 and over, Vantage offers several great Medicare Advantage plans as an alternative to Medicare. One benefit to Vantage's Medicare Advantage plans is that a network of providers is already contracted with the plan throughout Louisiana. These physicians, hospitals and specialty medical facilities have already agreed to provide health care services to treat Medicare Advantage members.

### OGB Group Plans (Secondary to Medicare)

1) **Pelican HRA 1000**- OGB's Pelican HRA 1000 plan offers low premiums in combination with employer contributions to create an affordable option for many members in 2015. The HRA 1000 includes an employer contribution in a health reimbursement account that can be used to offset deductible and other out-of-pocket health care costs throughout the year. Any unused funds rollover up to the in-network out-of-pocket maximum, allowing members to build up balances that cover eligible medical expenses when they happen. The Pelican HRA 1000 plan offers coverage within Blue Cross's nationwide network as well as out-of-network benefits to ensure members have a broad network of care.

2) **Magnolia Local**- Magnolia Local plans offer lower deductibles than the Pelican HRA 1000 in exchange for higher premiums. The Magnolia Local plan is a traditional plan that offers \$25 primary care co-pays (excluding wellness visits) and \$50 specialty care co-pays for members who live in specific coverage areas. Shreveport, New Orleans and Baton Rouge networks are currently available for OGB members. This plan is ideal for members who live in the parishes within the available networks and don't plan to utilize out-of-network care. However, out-of-network care is provided in emergencies.

a. **Community Blue** - Community Blue is a select, local network product designed for members who live in the Baton Rouge (East & West Baton Rouge and Ascension Parishes) and Shreveport communities (Caddo and Bossier Parishes). This means healthcare providers work as a team led by a primary care doctor.

b. **BlueConnect**- BlueConnect is a select, local network product designed for members who live in

the New Orleans community (Orleans and Jefferson Parishes). BlueConnect is a great health plan for people who want local access, a new approach to health and a lower priced insurance plan.

3) **Magnolia Local Plus**- The Magnolia Local Plus option offers the same coverage as the Magnolia Local plan with the benefit of a nationwide network. The Local Plus option offers \$25 primary care co-pays (excluding wellness visits) and \$50 specialty care co-pays for OGB members in any region. The Local Plus plan is ideal for members who prefer the predictability of co-payments rather than using employer funding to offset out-of-pocket costs. This plan provides care in Blue Cross's nationwide network. Out-of-network care is provided in emergencies.

4) **Magnolia Open Access**- The Magnolia Open Access Plan offers coverage both inside and outside of Blue Cross's nationwide network. It differs from the other Magnolia plans in that members enrolled in the open access plan will not pay co-payments at physician visits. Instead, once a member's deductible is met, he or she will pay 10% of the overall bill for in-network care and 30% of the overall bill for out-of-network care. Though the premiums for the open access plan are higher than OGB's other plans, its moderate deductibles combined with a nationwide network make it an attractive plan for members who live out of state or travel regularly.

5) **Vantage Medical Home HMO**- Vantage's Medical Home HMO is a patient-centered approach to providing cost effective and comprehensive primary health care for children, youth and adults. The Medical Home HMO plan creates partnerships between the individual patient and his or her personal physician and, when appropriate, the patient's family.

**This year you are required to make a selection during the annual enrollment period.** If you have OGB secondary coverage and do not make a selection by the end of the enrollment period, you will still retain your Medicare coverage but will be moved into the Pelican HRA 1000 as your secondary coverage.

fer, and Executive Director Graig Luscombe officially registered LRTA's opposition with the committee.

Prior to that meeting, both the Louisiana Retired Teachers Association and the Retired State Employees Association worked ferociously to convince some members of the joint committee that privatization of the state's health insurance plan would have future negative impacts on retirees. At the first meeting of the joint committee, the contract between OGB and Blue Cross/Blue Shield was deferred. Following that meeting, some of the committee members were removed by the Speaker of

the House, and replaced by other members of the House of Representatives, and the joint committee voted for the approval of the contract at a meeting held the following week.

Since that time, LRTA has closely monitored the changes brought forth through the privatization by attending all OGB board meetings held since the Blue Cross/Blue Shield contract was approved. As a result of the privatization, we are now seeing the increase in premiums (implemented by OGB on July 1, 2014), and the reduction in benefits (to be implemented January 1, 2015) that were predicted by Dr. Taylor in April 2011.

LRTA is extremely concerned about our members, and all retired educators who, for whatever reason, may not be able to comply with the OGB Open Enrollment deadline, and who will subsequently be placed in the HRA 1000 plan. This plan, in our opinion, is not an appropriate plan for our members and other retired educators.

LRTA continues to oppose changes being made to the administration and operation of the state health care plans offered by the Office of Group Benefits.

### Taylor wins retiree run-off election for TRSL Board of Trustees

James A. Taylor, Sr., J.D., Ph.D., of Baton Rouge, has been elected to serve on the TRSL Board of Trustees as a retiree representative.

Results from the 2014 retiree run-off election were announced at the board's September meeting.

Taylor received 51.77% of the vote against Darlene L. LeBlanc, also of Baton Rouge, who finished with 48.23%.

Taylor has 30 years of service with St. Charles Parish Public Schools. During that time, he worked as a teacher, principal, and central office administrator. He also has many years of service in higher education.

Taylor's four-year term on the TRSL Board begins January 1, 2015. He is replacing William C. "Bill" Baker, Ed.D., who has served on the TRSL Board for the last 22 years.

The TRSL Board meets monthly to monitor investment performance, review System operations, and develop policies for the administration of the retirement plan. The board safeguards and manages assets TRSL holds in trust to provide retirement income for System members.
