There is one constant every year when the legislature goes into session: attacks on our retirement. And since we are the only organization working solely to protect our benefits, I realize the importance of making this a priority during my term in office.

The Executive Committee agreed that we should focus our combined meeting will be face to face or virtual. The Spring State meeting in April will also be decided based on state guidelines.

While we plan for contingencies, our focus is also on the state legislature. The Regular Session is slated to begin April 12 and end June 10, 2021. Our Legislative Committee and staff will evaluate all pre-filed legislation and take positions according to our legislative priorities.

We will call on our members to be "virtual activists" this legislative session! Through our Becoming a Virtual Activist series, LRTA will send out timely, informative emails with links to materials such as:

• Talking points and research explaining the benefits of our Defined Benefit plan and why

efforts on strengthening our relationship with Representatives and Senators. We will encourage local Units and Districts to conduct regular meetings with local legislators and invite nonmembers of LRTA to also attend these meetings. Our aim will be to have a more positive, symbiotic relationship with legislators instead of contacting them only when we need their vote on or against an issue.

Clyde Hamner also is serving as State Legislative Chair. Since we are able to meet through Zoom, the Legislative Committee can meet monthly. We are working on new and improved ways to contact our legislators and will encourage and members on these educate methods.

I know we are ready to see 2020 come to an end, so this seems like a Hybrid Plans and Constitutional Conventions put our plan at risk

2020 Second Special Session Update

The legislature called itself into a Special Session on September 28, 2020. One retirement Bill was filed, HB 97 (substitute bill to House Bill 36) by Rep. Tony Bacala, which would have provided for the reemployment of retirees during a declared emergency. LRTA SUPPORTED the bill. However, the bill did not pass. The Second Special Session of 2020 ended October 23, 2020.
