Changing of the Guard: why State Elections Have a Critical Impact on Retirement. As I work during my ninth year as Executive Director for the Louisiana Retired Teachers Association, we have experienced several political victories which includes successfully lobbying to block more than two dozen detrimental bills that could have had a negative impact on our retirement plan. Additionally, we received approval from the state legislature for two COLAs under current Louisiana statue.

Perhaps most importantly, we worked with the Teacher's Retirement System of Louisiana for two years to design and advocate for COLA reform that will provide more regular cost of living benefit increases on a more regular basis, starting approximately 2029.

If we've successfully defended our Defined Benefit (DB) Plan and start receiving COLAs on a more regular basis, then what should our membership focus on from a legislative perspective? (continued on pg. 2)

We are asking retirees to **support Constitutional Amendment No. 3** on the October ballot. This amendment raises the retirement debt payment from non-recurring state revenue from 10% to 25%

This fall is a very important time in state government as many legislators are term limited and new candidates will be asking voters for support. Perhaps their more importantly, there will be a changing of the guard within the Governor's office and several candidates are vying for the state's most influential political post.

When we see a dramatic change in the state's governing body, it is important to garner support from candidates on important retirement issues.

LRTA has attempted to contact each candidate with a five-question survey that revolves around these issues and has asked them to return the surveys to our office so that our membership can make an informed decision in the voting booth.

Although LRTA and our governing Districts do not endorse political candidates, we do encourage our members to vote for candidates that provide an affirmative answer to the five-question survey. These five issues include: supporting our current defined benefit structure, Cost-of-Living providing Adjustments and approving COLAs become available. as funds supporting teacher pay raises, opposing Constitutional Conventions include that retirement, and to seek the repeal of the WEP and GPO at the federal level.

The survey responses are available for download and updated weekly on the LRTA website at *lrta.net*/ 2023-survey/.

Typically, the response rate to these surveys is low. Please reach out to candidates in your area and ask them to complete and return the survey to the LRTA office in Baton Rouge. A copy of the survey and a list with all candidate contact information is also available for download in the same section on the LRTA website (*lrta.net/2023survey/*).

Regardless of the election outcomes we must remain vigilant during election years with a heavy term-limited turnover of legislators. The reason for this is twofold. First, many campaigns receive contributions from antipublic pension groups that expect winning candidates to support legislation that could change our defined benefit to a defined contribution plan which could produce or lower retirement benefits to recipients. Although we've seen a reduction in these attacks during the last couple of years due to our advocacy, it is during transition years that they tend to re-emerge. Second, even if candidates that generally support us are elected, the naively—elected official often votes against our legislative priorities due to a lack of knowledge.

Therefore, looking ahead we will need to pour a large amount of energy into surveying, communicating, and educating all new legislators in order to build and to support the good we have received from many of the legislators during the last nine years.

Although it sounds like we are starting over, the fact is that we've built the advocacy tools and resources we need to begin this process. Your part will be to reach out and begin this arduous process as we continue as an organization to defend and support our benefit plan. Inviting legislators (new and returning) to your Unit and District meetings is a good starting point.

If you presently do not participate, it is highly suggested you start by regularly attending the District meetings. The meetings take place bi-annually per district in the months of September and March. Also, consider subscribing to our email club which you can join on the LRTA website, and be sure to respond to calls to action at the appropriate times.

Finally, encourage all retirees to join LRTA. As I've stated in the past, if all you do is pay your dues, you are funding the lobbying and advocacy activities that keep our retirement plan whole.

A MESSAGE FROM OUR LRTA President



As illustrated in our advocacy this past legislative term, I am sure you all are aware of the impact of voting and being politically involved. Even if vou didn't vote, vou still made a difference if you contacted your legislators to encourage them to support SB 18 (now Act 184) for our COLA reform -as well as all the other issues that potentially can or currently are affecting retirees. Whether it was through letters, emails, phone calls, or trips to the Capitol, a difference was made through your voice. These actions are evidence of how much we can influence change.

Watching our elected officials act in the face of our retired educators was eye opening to how much of a difference our retirees can make. As LRTA President. I also want to mention that throughout my experience what I have treasured most through following the legislative seeing terms was how perspectives and opinions evolved on both sides of the bill that SB 18 faced.

Acting through advocacy never ends. Therefore, there is a need for us to be diligent in our quest to elect people who generally compliment their opinions with those of LRTA. Pay attention to candidates who are involved in their communities. Their actions are opportunities, which demonstrate firsthand the type of leadership they may possess. Seek these individuals out through the forums and become aware of candidates' agendas with the help of LRTA.

Because LRTA has formed a coalition with other groups, our voice is stronger. When we attend legislative sessions in numbers, our presence is felt. And what LRTA needs now is more numbers. This is a major reason I am pleading with active members to encourage others to join. Due to all members being at different stages in life, some cannot attend meetings. To alleviate this conflict one solution is to include them through Zoom from the meeting site. If this is not feasible, consider calling them with a little conversation about retired teachers. This may help keep them involved through other means. It doesn't matter how you do it, only that you do make the effort.

The objective of the LRTA is to keep the organization alive and growing-to serve its members through ongoing advocacy. The push is to recruit and retain members who have recently retired within the last six years and target teachers to approaching retirement. Educate active employees about our organization, emphasizing that the LRTA is the ONLY organization in the State of Louisiana that fights solely for retired teachers. Encourage present educators to join as associate members. Maintain open communication channels with associate members, which will naturally guide them towards active membership upon retirement. As LRTA members in the community and schools, inquire about getting LRTA's name on the School Board website and getting our brochures into teacher lounges. You can reach out to the LRTA staff for free brochures.

Lastly, with so much going on during these hot summer months, remember that fall is just around the corner. This means that so is the 2023 LRTA State Fall Meeting. Planning has been diligently done by office staff and District IV. The meeting will take place on October 16 and 17th at the Embassy Suites in Baton Rouge, LA. Please note correct dates of the the meeting are October 16-17th Registration is now open for the upcoming meeting.
