A MESSAGE FROM OUR EXECUTIVE DIRECTOR



During the last year the Louisiana Retired Teachers Association (LRTA) has focused on politics, people, and places.

In terms of politics, the Louisiana State Legislature convened its regular legislative session on Monday, March 11, 2024, and final adjournment will be no later than 6 p.m. on Monday, June 3, 2024.

During the preparation of this newsletter, LRTA is tracking six pieces of legislation ranging from technical amendments, and return to work to restrictions regarding fiduciary responsibilities of retirement boards.

The most important bill that LRTA is monitoring is SB 5 by Senator Blake Miquez that will restrict how retirement boards can invest regarding environmental, social and government companies.

This legislation is troublesome because these restrictions would have a profound and negative impact on our investment returns and almost certainly create more debt and eliminate any chance for cost-of-living increases in the future.

LRTA opposes SB 5 in its original form and supports the TRSL Board's

essential mission to invest in any companies that provide for the greatest return at the lowest possible risk.

Included in this edition on page five are talking points describing why this legislation would have a negative impact on retirement plans statewide. Also included on page four is information for other bills LRTA is tracking regarding our retirement plan.

LRTA and TRSL will work with Senator Miquez to amend the bill into a posture that would not have a negative effect on our retirement plan. If our efforts are unsuccessful, we will provide our members with talking points, sample letters and contact information for legislators at the district meetings in March. A complete listing of meetings can be found on our website at lrita.net.

BILLS TO WATCH IN THE 2024 REGULAR SESSION

Below are bills that the Louisiana Retired Teachers Association (LRTA) and the Teacher Retirement System of Louisiana (TRSL) are presently tracking. Real time updates can be found on the LRTA website at lrtanet.org.

Bill No.	Status	Description	Position
SB 5	Pending Senate Retirement	<p>Proposes to define "financial" as having been prudently determined by a fiduciary to have a material effect on the financial risk or the financial return of an investment. Further defines "financial" as not including any action taken, or factor considered, by a fiduciary with any purpose whatsoever to further social, political, or ideological interests.</p> <p>Proposes that a fiduciary may reasonably be determined to have taken an action, or considered a factor, with a purpose to further social, political, or ideological interests by engaging in what is defined in the proposed law as a "fiduciary commitment" (see definition below) to further, through portfolio company engagement, board or shareholder votes, or otherwise as a fiduciary, any of the following beyond what controlling federal or state law requires:</p> <ul style="list-style-type: none">• Eliminating, reducing, offsetting, or disclosing greenhouse gas emissions.• Instituting or assessing corporate board, or employment, composition, compensation, or disclosure criteria that incorporates characteristics protected in this state.• Divesting from, limiting investment in, or limiting the activities or investments of, any company, for failing, or not committing, to meet environmental standards or disclosures.• Access to abortion, sex or gender change or transgender surgery.• Divesting from, limiting investment in, or limiting the activities or investments of, any company that engages in, facilitates, or supports the manufacture, import, distribution, marketing or advertising, sale, or lawful use of firearms, ammunition or components parts and accessories of firearms or ammunition. <p>Provides that anyone found to have breached these duties is liable for damages equal to three times all monies paid to the person or company by the system for that fiduciary's services.</p>	OPPOSE IN ITS ORIGINAL FORM
HB 31	Pending House Retirement	<p>Proposes to allow active, contributing participants in the ORP as of June 30, 2024, to make a one-time choice to join the TRSL defined benefit plan.</p> <ul style="list-style-type: none">• Must be in writing and received by TRSL on or before December 30, 2024.• For those who make this choice, ORP contributions cease on January 31, 2025, and contributions and service accrual in the TRSL defined benefit retirement plan begin on February 1, 2025, as a member first eligible for membership on that date.	NEUTRAL
HB 17 (Return to Work)	Pending House Retirement	<p>Proposes to temporarily allow most retirees to be reemployed through a contract or corporate contract without any suspension of their retirement benefit.</p> <ul style="list-style-type: none">• Benefit reduction rules remain in place.• Does not apply to disability retirees, those returning to work within a year of retirement, certain retirees filling critical shortages at higher education institutions, or voluntary suspension in lieu of benefit reduction. <p>Proposes that rehired retirees under contract or corporate contract and their employers will be exempt from employee and employer contributions during the reemployment.</p>	NO POSITION
HB 35 (Return to Work)	Pending House Retirement	<p>Proposes to allow a retiree who retired after June 30, 2020, to return to work in critical shortage positions without a one year waiting period or a reduction or suspension of benefits if there are no other properly certified non-retiree candidates to fill the vacancy.</p> <p>Does not apply to disability retirees or certain retirees filling critical shortages at higher education institutions. Requires that any cost of proposed law be funded with additional employer contributions.</p>	NO POSITION
SB 1	Pending Senate Retirement	Current law provides for the transfer of all employee and employer contributions when an employee transfers from one public retirement system to another.	NEUTRAL

OPPOSE Senate Bill 5 In Its Original Form

How SB 5 and ESG Legislation could affect our benefit plan:

ESG stands for Environmental, Social, and Governance and is a hot topic in the worlds of investment and politics. ESG is a set of standards or criteria used by investors who want to consider more than just a company's financial performance when evaluating the risks tied to making an investment.

- **Environmental criteria** can focus on a company's environmental footprint, including energy use and corporate policies addressing climate change.
- **Social criteria** can examine if a company is being a good corporate citizen by looking at its treatment of employees, relationships with customers as well as its impact on communities and society at large.
- **Governance criteria** can delve into a company's managerial composition and compensation, its ethics and transparency. Some believe use of ESG criteria gives investors broader insight into investment risks. A company may have an impressive profit margin, but lack quality control measures that ensure it complies with government regulations. By adding ESG criteria to the mix, investors consider a multitude of risk factors in projecting a company's long-term stability, value, and earnings potential.

ESG has drawn criticism for injecting non-financial factors into investment decisions. Each plank in ESG often means different things to different people. Proponents might use ESG criteria as a metric for measuring relevant business concerns, such as a business location or audit results. Opponents might say that ESG is concerned with social outcomes untethered to financial returns. Therein lies the frustration for those entrusted with making investment decisions for thousands of retirement system members.

For example, if a law is passed restricting investments in companies that do not report on their environmental impact, that would be ESG. Alternatively, if an anti-ESG law is passed stating that investors cannot take into account a company's environmental impact, that would likewise be ESG. The issue of ESG is highly subjective.

How does this impact you? Retirement system investments are usually overseen by boards of trustees, executive administrators, and investment professionals and consultants. These individuals are considered fiduciaries responsible for always acting in the best interest of retirement system members. They bear personal liability should they fail to fulfill their fiduciary duties. These fiduciary responsibilities include making prudent investment decisions (maximizing returns and minimizing risk) and following a sound investment policy to pay retirement benefits to retirees and their beneficiaries.

What is the impact of ESG laws? A diverse investment portfolio and a strong asset allocation are key to achieving the best return on investments. When opponents or proponents of ESG seek to restrict or expand the use of ESG criteria in investment decision-making, a cascading effect takes place. ESG directives that restrict or compel investment in certain areas can lead to increased fees and a loss of investment opportunities across those areas as well as other unintended consequences.

An ESG hypothetical: Suppose an ESG law passes that prohibits a retirement system from investing in any company that has pledged to cut its greenhouse gas emissions to zero by 2050 (net-zero emissions).

The intent of the law is to support a state's oil and gas industry that employs thousands workers. However, the unintended consequence is that investments in ExxonMobil and Shell Global—companies with huge workforces in the state—would be forbidden because they have long-term plans to achieve net-zero emissions by 2050. So, what is the result? The new law not only undermines its stated intent to support Louisiana's oil and gas industry, it also limits a retirement system's option to invest in a business—even when the investment is likely to produce stable returns. In simple terms, ESG can create subjective directives that disrupt a fiduciary's duty to act in the best interests of the retirement plan and its members.


