2008 Regular Legislative Session — Final Update

The Louisiana Legislature adjourned the 2008 Regular Session sine die at 6:00 p.m. on Monday, June 23, 2008. The following summary provides actions taken by the legislature on bills being monitored by the LRTA staff. The status of the bill at the end of the session is indicated in red.

* * * * * * * *

House Bill No. 89 by Representative Jean Doerge and Representative Jack Montoucet will allow future participants in the Deferred Retirement Option Plans of both the Teachers' Retirement System of Louisiana and the Louisiana State Employees' Retirement System to select interest payments on DROP account deposits that would equal 0.5% less than the systems' actuarial rates of return.

Members would have to sign a waiver of constitutional rights that currently protect retirement benefits so that individual DROP accounts could be reduced if the systems' actuarial rates of return were negative in any given year. Individuals who began participation in DROP on or after January 1, 2004 may only earn money market rates of return on their DROP accounts. Amended by the Senate to require the boards of trustees of the Teachers' Retirement System of Louisiana and the Louisiana State Employees' Retirement System to separately file for a declaratory judgment on the issue of whether or not a member can waive their constitutional rights. The effective date was moved to July 1, 2009, or 60 days after each system obtains a final non-appealable judgment. Became Act 714.

House Bill No. 90 by Representative Jean Doerge, Representative Jerome "Dee" Richard, and Representative Harold L. Ritchie will permit the Teachers' Retirement System of Louisiana to deposit sufficient funding in the Employee Experience Account to provide for three, instead of two, costof-living adjustments. This is LRTA's bill. Referred to the House Retirement Committee. The bill failed to pass. As a result of testimony provided to the committee on May 14, 2008 House Study Resolution No. 14 was developed. This resolution requests further study on future COLAs (see below).

House Bill No. 259 by Representative St. Germain provides an appropriation from Fiscal Year 2008-2009 revenues in the amount of \$130,000,000 to the Teachers' Retirement System of Louisiana to accelerate the payoff of the Initial Unfunded Accrued Liability of the retirement system. The bill failed to pass.

House Bill No. 457 by Representative Nita Hutter provides an appropriation of \$5,600,000 for the payment of health insurance premiums to the Office of continued on page 3

From the Desk of the President

The legislators have gone home from the 2008 Regular Legislative Session. The session was one of mixed reactions from all sides. I feel the legislators do deserve adequate compensation for their work and sacrifices

due to special sessions, regular sessions and the continuing work with their constituents back home. It has been many years since their base compensation has been raised. I also feel that whatever compensation package they pass in the future should tie their cost-of-living adjustments to COLAs retired teachers receive annually! The 3% cost-of-living adjustment approved by the legislature has been paid from the TRSL Experience Account as of July 1, 2008 to those eligible retirees. Over the past six years, the two COLAs received averages only 1% per year. This is not adequate for retirees who have contribut-

ed so much through decades of service for the betterment of the citizens of Louisiana. The solution to this dearth of COLAs is for the administration and legislature to expend funds annually from the general fund for supplementing the TRSL Experience Account in order to provide ongoing and consistent COLAs for our retired education professionals. Over one-half of the other states in this country use general fund appropriations to fund COLAs for their retired education professionals. It is time for Louisiana to join these ranks.

The LRTA Executive Committee met in July to review where we are and plan for the future. The committee discussed expanding the 2008 Legislative Priorities of LRTA. The members of the committee were disappointed with the promotion of school vouchers by the governor and the legislature. Funds cannot be siphoned off to support private schools without negatively impacting

Executive Director's Report

The LRTA Executive Board and staff want to thank all of the members of the Louisiana legislature for the support provided on the passage of Senate Concurrent Resolution No. 1, which provided authority to the Board of Trust-

ees of the Teachers' Retirement System of Louisiana (TRSL) to grant a 3% cost-of-living adjustment to all eligible retirees and to the beneficiaries of retired educators on July 1, 2008. We also want to thank the board of trustees and the staff of the Teachers' Retirement System of Louisiana for their hard work in making the COLA possible. This COLA is cumulative, meaning it will be added to the gross benefit amount you were already receiving from the retirement system.

LRTA especially thanks Senator D. A. "Butch" Gautreaux of Morgan City for authoring the

COLA resolution, and Representative Joel C. Robideaux of Lafayette for co-authoring the resolution. These gentlemen provided the leadership and support needed to guide this resolution through the legislative process.

The board and staff also want to say a special "thank you" to Representative Jean M. Doerge from Minden, and to Senator B. L. "Buddy" Shaw of Shreveport. These legislators introduced House Bill No. 90 and Senate Bill No. 35 on behalf of LRTA, which would have allowed the TRSL Board of Trustees to deposit an amount into the Employee Experience Account sufficient to pay a third cost-of-living adjustment. In accordance with current law, the board may now only deposit funds sufficient to pay two cost-of-living adjustments.

House Bill No. 90 was heard by the House Committee on Retirement on May 14, 2008. Representative Doerge presented

Legislature Honors Memory of Dr. Wade Ledet

Upon learning of the sudden and unexpected death of LRTA President Dr. Wade Ledet in March, members of the Louisiana legislature authored three resolutions honoring Dr. Ledet for his commitment to education in Louisiana. Senate Concurrent Resolution 22, by Senator Butch Gautreaux, reads:

A CONCURRENT RESOLUTION

To express the sincere condolences of the Legislature of Louisiana upon the death of Dr. Wade L. Ledet.

WHEREAS, it is with great sorrow and sadness that the legislature and the citizens of Louisiana have learned of the death of Wade Luke Ledet, Ed. D.; and

WHEREAS, born on May 10, 1933 to Sylves and Eliza Ledet, Wade Luke Ledet was a native of Larose, Louisiana; and

WHEREAS, Wade Luke Ledet graduated from Larose-Cut Off High School in 1952, and, after graduation, he honored his state and country by enlisting and serving in the United States Air Force; and

WHEREAS, Wade Luke Ledet went on to further his education by obtaining a Bachelor of Art degree in Social Studies Education from Nicholls State University in 1959, a Master of Education degree in Guidance and Psychology from Northwestern in 1964, and a Doctor of Education degree from the University of Mississippi in 1970; and

WHEREAS, Dr. Wade Luke Ledet had a long and distinguished career in education, teaching in the Lafourche Parish schools and at Nicholls State University, retiring as the Dean of University College and Professor of Counselor Education in 1989; and

WHEREAS, upon his retirement Dr. Ledet was appointed director of the Job Link Center at Nicholls State University; and

WHEREAS, Dr. Ledet was a progressive voice for education in Louisiana as he dedicated his time and efforts championing causes of retired teachers throughout the state, serving as the president of the Lafourche Retired Teachers Association, the president of District II of the Louisiana Retired Teachers Association, the first vice president of the Louisiana Retired Teachers Association, and as the president of the Louisiana Retired Teachers Association; and

WHEREAS, he was a devout member of St. Thomas Aquinas Catholic Church in Thibodaux, Louisiana, and was former deputy grand knight, a fourth degree of the Knights of Columbus Council 3150; and

WHEREAS, he was a loving, devoted, and dedicated husband of fifty-four years to his loving wife Alice, a cherished and committed brother, uncle, relative, and friend whose love of family was of utmost importance in his life; and

WHEREAS, this extraordinary man clearly demonstrated during his life his dedication to his job, community, family, state, and his country; and

WHEREAS, his numerous accomplishments in public and private life reflected his bravery, heroism, compassion, and commitment to education; and

WHEREAS, upon his sudden and unexpected death on March 19, 2008, the world lost a unique individual who left an indelible mark upon his community and the lives of all those who knew him; and

WHEREAS, as we seek to offer his family

whatever comfort we can, we want them to know that their fellow citizens are aware of their loss, and desire to commend Dr. Wade L. Ledet on his commitment to education in Louisiana, and extend Louisiana's most sincere condolences.

THEREFORE, BE IT RESOLVED that the Legislature of Louisiana honors Wade Luke Ledet, Ed. D., pays tribute to his remarkable legacy, and offers their sincere condolences to his family, on behalf of all the citizens of the state of Louisiana.

BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to his wife, Alice R. Ledet.

House Resolution 14 by Rep. Jerome Richard and Senate Resolution 8 by Sen. Joel Chaisson expressed the same sentiments.

Group Benefits for retiree for the period July 1, 2008 through June 30, 2009. The bill failed to pass. However, an appropriation of \$4,777,768 was included in House Bill No. 1287, the Supplemental Appropriations Bill for the school boards of the city of Bogalusa, Cameron Parish, Orleans Parish, Plaquemines Parish and St. Bernard Parish. House Bill No. 1287 became Act No. 511.

House Bill No. 482 by Representative Cedric Richmond will allow the Office of Group Benefits to offer the purchase of prescription drugs through mail order with no penalty to the plan participant—either active employee or retiree. The bill failed to pass.

House Bill No. 827 by Representative Page Cortez provides an appropriation from Fiscal Year 2007-2008 revenues in the amount of \$654,000,000 to the Teachers' Retirement System of Louisiana to accelerate the payoff of the Initial

Unfunded Accrued Liability of the retirement system. The bill failed to pass.

House Study Resolution No. 14 by Representative Jean Doerge requests the House Retirement Committee to study provisions by which cost-of-living increases are granted to eligible retirees and beneficiaries of the Teachers' Retirement System of Louisiana and of the Louisiana State Employees Retirement System. Adopted by the House on June 20, 2008.

<u>Senate Bill No. 35</u> by Senator B. L. "Buddy" Shaw is the same as House Bill No. 90. <u>This is LRTA's bill.</u> The bill failed to pass.

Senate Bill No. 87 by Senator B. L. "Buddy" Shaw provides relative to Louisiana personal income taxes, and amends "the Stelly Plan" by reducing current rates and tax brackets. Tax re-

Foundation Plans

In preparation for a March/April 2009 Rally of Retirees at the Capitol in Baton Rouge, plans must be made to have an effective, efficient and energized event. The purpose of this rally will be to urge legislators and the governor to provide general appropriation funds to supplement the Employee Experience Account in order to provide ongoing and consistent cost-of-living adjustments for TRSL retirees. Resources are necessary to implement these plans. Donations to the Foundation for this purpose are extremely important. At this stage of preparation, each Unit President is requested to hold a fund raising event in support of these

efforts. District Presidents are asked to help coordinate these events with units in their region. As these plans are made at the local level, please share the progress with the LRTA office so that the successes can be published in upcoming LRTA Newsletters. Many of our retirees will need transportation provided to the Capitol and some mobile assistance when on the grounds. Many will carpool, so we need funds to pay for gasoline expenses. Chartered buses may be needed to pick up retirees in the outlying areas as well as the four corner regions and borders of the state. Ask your corporate neighbors and local businesses to donate to this worthy cause. Historically, in Louisiana the COLAs have been few and far between. Over 50% of the states provide monies from the state's general fund to pay COLAs. We should not expect less from Louisiana. Our cause is right, just, and the need is real. The Employee Experience Account with the legislative restrictions is inadequate to provide ongoing and consistent COLAs for our deserving retired teachers. It is time for supplementary funds to be appropriated for this purpose. More information will be forthcoming as plans and preparations progress.

concerns of LRTA to the committee regarding future COLA payments. Dr. Craft and I, along with Ms. Maureen Westgard, the director of TRSL, also had an opportunity to present testimony to the committee. After much discussion, the committee decided to take a further look at concerns expressed during the hearing on the bill. As a result, Representative Doerge introduced House Study Resolution No. 14. House Study Resolution No. 14 was passed by the House of Representatives on Friday, June 20, 2008, and requests the

House Committee on Retirement to study the mechanics by which COLAs are granted to retirees of both the Teachers' Retirement System of Louisiana, and of the Louisiana State Employees' Retirement System.

LRTA looks forward to working with the committee and the retirement systems in gathering and providing any information that will be helpful in completing the study. We will keep you informed of developments regarding the study.

Deadline Approaches for Hurricane-Related Drop/ILSB Redeposits

The deadline to redeposit DROP/ILSB funds some members received after Hurricanes Katrina and Rita is drawing near. State law allows any retiree who received a DROP/ILSB qualified hurricane distribution before January 1, 2007, to redeposit all or part of those funds back into their DROP accounts. However, this repayment must be received by TRSL within three years from the date the funds were withdrawn from TRSL.

These DROP/ILSB distributions were made under provisions of the Katrina

Emergency Tax Relief Act of 2005 (KETRA) and the Gulf Opportunity Zone Act of 2005 (GO Zone). TRSL made the first of these distributions in December 2005, which would make the redeposit deadline December 2008.

If you want to repay all or part of your qualified hurricane distribution, please submit the DROP or ILSB Qualified Katrina Emergency Tax Relief Act of 2005 (KETRA) or Gulf Opportunity Zone Act of 2005 (GO Zone) Withdrawals Repayment (Form 11-RD) and

your check to TRSL within three years of the date of your distribution.

The form may be found on TRSL's website, www.trsl.org. For federal reporting requirements, refer to IRS Form 8915. It may be found at the IRS website, www.irs.gov.

ductions are to be implemented by the Secretary of the Department of Revenue on July 1, 2009. The bill passed, and became Act No. 396.

Senate Bill No. 328 by Senator Nicholas "Nick" Gautreaux and others is a constitutional amendment that would provide for a tax refund or a tax rebate to anyone required to file a Louisiana individual income tax return. The rebate or refund would have to be authorized by law enacted by the legislature each time the rebate or refund would be paid. The rebate or refund will be paid from surplus revenues collected by the state in any given fiscal year. The bill failed to pass.

<u>Senate Bill No. 502</u> by Senator A. G. Crowe is the same as House Bill No. 482. The bill failed to pass.

Senate Bill No. 595 by Senator John Smith is similar to House Bill 89, but will only allow DROP participants of the Teachers' Retirement System of Louisiana the new option. LASERS DROP participants are not included in the proposed legislation. The bill failed to pass.

Senate Concurrent Resolution No. 1 by Senator D. A. "Butch" Gautreaux and Representative Joel Robideaux authorizes the Teachers' Retirement System of Louisiana to grant a 3% cost-of-living adjustment on July 1, 2008. The

resolution was adopted, and the COLA became effective July 1, 2008.

In addition to bills summarized above, there are a number of bills that were monitored by LRTA. They include:

House Bill No. 108 by Representative Jeffery "Jeff" Arnold makes permanent the current temporary provisions that require all state retirement systems to direct trades of certain securities through Louisiana incorporated and domiciled broker-dealers. The bill failed to pass.

House Bill No. 226 by Representative James K. Armes, III will allow individuals receiving disability retirement benefits from the Teachers' Retirement System of Louisiana to return to work as a substitute teacher. Current law requires that disability benefits be suspended when a recipient returns to work in the field of education, either public or private. Although this bill will benefit retired educators, there will be an actuarial cost. Therefore, based upon LRTA's 2008 Legislative Priorities, the LRTA staff will be monitoring the progress of this bill. The bill failed to pass.

House Bill No. 1208 by Representative Reed Harrison increases the allocation of trades of certain securities to be directed by state retirement systems to Louisiana incorporated and domiciled

broker-dealers from 10% to 25%. The bill failed to pass.

House Bill No. 1347 by Representative Austin Badon, Jr. establishes a pilot program to provide vouchers to families with children attending schools governed by the Orleans Parish School Board. Vouchers will be used by the children to attend a non-public school of their choice. Became Act 509.

House Resolution No. 78 by Representative Jeffery Arnold requests the legislative auditor to conduct a performance audit of the state retirement systems relative to the legal requirement that they direct certain percentages of investment trades through La. brokerdealers. The resolution was adopted.

None of the bills regarding the forfeiture of retirement benefits upon the conviction of certain felony crimes passed. Bills regarding this topic included House Bill Nos. 740, 783, 1013, 1022, 1237, 1263, and Senate Bill Nos. 27, 310, and 639.

The following resolutions were passed in memory of Dr. Wade L. Ledet.
