Executive Board EndorsesLA Self Help Plan at Fall Meeting

The Fall Meeting held in Lafayette on October 19, 20 and 21 was a great success. The Executive Board and the membership congratulate LRTA District V for a job well done. On Tuesday, October 20, the Executive Board endorsed the LA Self Help Plan, developed by Mr. J. Ronald Eldridge, which promises to provide revenues to the state of Louisiana that could be used to address concerns of the LRTA membership. Mr. Eldridge presented his plan to the LRTA membership in attendance at the Fall Meeting prior to the action taken by the Executive Board to endorse the plan. Dr. Craft's message, "From the Desk of the President", provides further information regarding the plan, and summarizes other items considered by the Executive Board during the meeting proceedings.

Featured speakers during the two days of general sessions were District Attorney J. Phil Haney, who gave a presentation on the Prosecutor's Early Intervention Program of the 16th Judicial District of Louisiana, and Lafavette Superintendent Burnell Lemoine, who provided information on the innovative programs being implemented in Lafayette Parish schools. A highlight of the meeting was a panel discussion on legislative matters of interest to retirees by Senator D. A. "Butch" Gautreaux and Representative Joel C. Robideaux, chairs of the Senate and House Retirement Committees. Rounding out general session presentations were agency updates from Maureen Westgard, Director of the Teacher' Retirement System of Louisiana, and Tommy Teague, CEO of the Office of Group Benefits.

Entertainment for the two dinner banquets was provided by local talent from the Acadiana area. Musician Paul Wiltz performed during the Monday night banquet, after which vocalists Sheena Narcisse and Sherita Matthews delighted the audience. Michael

and Martha Bryant provided music during the Tuesday night dinner, followed by storyteller Ginger Cormier, who amused the crowd with tales of classroom antics collected during her long teaching career. Mrs. Bryant is the newly-elected president of the St. Martin Association of Retired Teachers.

Guests of honor for the Tuesday night banquet were Carilyn Ashcroft of Winnfield, and LeRoy Washington of Port Allen. Mrs. Ashcroft and Mr. Washington, recipients of the LRTA Name of Fame award, were presented Name of Fame medallions and certificates. Congratulations to Mrs. Ashcroft and Mr. Washington, who join an elite group of LRTA members who have been bestowed the honor since the program's inception in 2002.

LRTA extends many thanks to District V Host Committee chair Jerry Caillier, co-chairs Hazel Turner and Bonnie Lyons, all committee members, the local units, all the members of District V, and last but not least, district president James Broussard, for an outstanding job in hosting and helping with arrangements for the 2009 Fall Meeting. Next year's Fall Meeting will be co-hosted by LRTA Districts IX and X.

Broussard for his noted leadership. Special recognition is certainly in order for Mrs. Jerry Caillier as chairperson for the event. Her involvement, planning and work efforts were evident throughout the Fall Meeting. Executive Director Graig Luscombe, Assistant Director Renee Siccone and Membership Coordinator Ann Reed evinced their expertise again in the pre-planning with preparation, on-site implementation of details and post-meeting follow-up of the 2009 Fall Meeting. For this I say a much deserved "THANK YOU"! Mrs. Renee Siccone was presented with a memento for 35 years of service to LRTA. This conference chalked up her 69th meeting in which she was involved for LRTA. This is a milestone of personal achievement by Assistant Director Siccone that merits our appreciation and congratulations.

The LRTA Executive Board covered an extensive agenda during the Fall Meeting in taking care of important business before the group. It received and acted on committee reports and recommendations from the Executive, Audit, Legislative, and Nominating Committees. It heard reports from the Foundation, Office of Group Benefits, TRSL, and AARP. The Executive Board recessed on Monday to hear a presentation by Mr. J. Ronald Eldridge on Tuesday relative to his LA Self Help Plan. After hearing the Eldridge Plan, the LRTA Executive Board reconvened and voted to endorse the plan. This plan is our last, best hope to continue a decent quality of life. Two things must happen relative to the Eldridge Plan: (1) an excise tax on pipe-

Executive Director's Report

The 2010 Regular Legislative Session begins at noon on Monday, March 29. The Executive Board has adopted LRTA's 2010 Legislative Priorities found in this issue. Already, the legislature has been gearing up for the next session, and

there are a number of issues that will be discussed that are of great interest to the membership. Hearings are being held to consider the development of a defined contribution retirement plan for new members joining the Teachers' Retirement System of Louisiana (TRSL). Defined contribution plans base future retirement benefits on the amount of money accumulated in an individual member's retirement account, rather than being based on a formula that determines the retirement benefit—a defined benefit plan. LRTA opposes the switch from a defined benefit plan to a defined contribution plan for TRSL members joining the system after July 1, 2010.

Another topic that may be considered is funding of TRSL and future permanent benefit increases, which were formerly referred to as cost-ofliving adjustments. Senator D. A. "Butch" Gautreaux and Representative Joel C. Robideaux joined the LRTA membership at the Fall Meeting in Lafayette to discuss the provisions of Act No. 497 of 2009. This act altered the method by which future permanent benefit increases may be granted by TRSL.

The Commission on Streamlining Government has been meeting diligently to satisfy its legislative mandate to report on methods by which Louisiana state government can operate more efficiently and effectively. The commission's report is due by December 15, 2009. Some of the recommendations to be submitted by the commission may impact you as a retired educator. Once finalized, LRTA will review the report and keep members informed about its findings and recommendations.

Additional topics that may be discussed include the consolidation of TRSL with other retirement systems, placing limitations on the investment practices of the retirement systems, retiree continued on page 8

lines must be put into an act by the Louisiana legislature and approval by the governor, and (2) it must be tested in the federal courts to determine whether it is acceptable under the U.S. Constitution. The Eldridge Plan is not a property tax. This excise tax on pipelines in Louisiana would not be in violation of interstate commerce standards because individuals and businesses would pay the same rate in Louisiana as those states outside Louisiana. This is one of the reasons that Governors Edwards', Treen's and Roemer's taxes on oil and gas were declared unconstitutional -- because the acts exempted Louisiana citizens from paying these taxes. Ninety-eight percent of the proposed excise tax would be paid by those outside of Louisiana. There is a precedent set by the U.S. Supreme Court in a decision declaring a Montana excise tax constitutional. Montana passed a 30% excise tax on coal mined in Montana, used in Montana, and shipped elsewhere. Due to the strip mining for the coal, much of the landscape was destroyed. The revenues from this tax were used to correct the damages done by the strip mining and also help the citizens and businesses of Montana have an improved quality of life.

The multiplicity of pipelines bringing in gases and liquids has taken its toll in the destruction of the Louisiana coastline over a 70-year period. The federal government has not come forward to make a difference in significantly rebuilding the

Louisiana coast. Revenues of about \$99 billion dollars of the \$198 billion anticipated to be collected annually under the plan could restore the Louisiana coast line to its 1900 condition. This would help protect the citizens from the devastating onslaught of hurricanes we have been experiencing over the last decades. Barrier islands could be restored and a solid coastline revamped that would provide us with a true sportsman's paradise. The other \$99 billion would bolster the Louisiana economy and help every woman, man and child in the state. Our retired teachers, firemen, police and other public employees would receive substantial benefits from the enactment of the Eldridge Plan. Businesses would flourish in the state and high-quality businesses would move here for the zero-tax structure. Our children and grandchildren would stay in the state with good paying jobs and those that left will come back because of the improved business climate, employment opportunities and a great quality of life. In order for this to come to pass, Louisiana citizens and businesses must take a BOLD STEP FORWARD TO THE FUTURE!

The LA Self Help Plan calling for an excise tax on pipelines in Louisiana could provide revenues to:

1) Increase the base pensions for retired teachers by \$3,000 per month and pay off the unfunded accrued liabilities of the Teachers Retirement System of Louisiana, thus leaving the earnings of the system to pay consistent permanent benefit increases.

RESOLUTION

WHEREAS, The Executive Board and the members of the Louisiana Retired Teachers Association remain concerned about the purchasing power of the benefits received from the Teachers' Retirement System of Louisiana; and

WHEREAS, Act No. 497 of the 2009 Regular Legislative Session adjusted the provisions under which future Permanent Benefit Increases may be granted to eligible retired educators and other benefit recipients; and

WHEREAS, The Louisiana Constitution prohibits changes in the benefit structure offered by the retirement system that increase the unfunded accrued liabilities of the system unless a viable revenue source is identified that can provide payment for the adjustments over a ten year period; and

WHEREAS, The Louisiana Retired Teachers Association has become aware of a plan developed by Mr. J. Ronald Eldridge known as the Louisiana Self Help Plan; and

WHEREAS, The plan provides for the levy of an excise tax on pipelines that carry liquids and gases moving through Louisiana; and

WHEREAS, The plan would generate sufficient revenue to provide full funding of the Teachers' Retirement System of Louisiana as well as for providing benefit adjustments and future Permanent Benefit Increases,

NOW, THEREFORE, BE IT RESOLVED, That the Louisiana Retired Teachers Association endorses the Louisiana Self Help Plan for the purposes mentioned above,

RESOLVED That this resolution be provided to the governor, members of the legislature, and other elected officials; and

RESOLVED That this resolution be made a part of the minutes of the proceedings of the Executive Board of the Louisiana Retired Teachers Association from the Fall Meeting held in Lafayette, LA on October 19, 20, and 21, 2009.

2010 Legislative Priorities

LRTA supports legislation that will positively affect retired teachers and opposes legislation that will adversely affect retired teachers. LRTA also supports efforts to maintain adequate funding for top quality public education in Louisiana. Although these priorities are listed in numerical order, the items listed are all top priorities of LRTA.

- 1. LRTA supports a viable Employee Experience Account for accumulating a portion of the excess interest earnings of the Teachers' Retirement System of Louisiana for future funding of permanent benefit increases (PBIs) for retirees.
- 2. LRTA supports dedicated allocations from state funds for permanent benefit increases.
- 3. LRTA supports a stable, automatic permanent benefit increase provision for retirees as part of the benefit structure offered by the Teachers' Retirement System of Louisiana.
- 4. LRTA supports dedicated allocations from state funds to meet the state's obligation to reduce the Initial Unfunded Accrued Liabilities (IUALs) of the Teachers' Retirement System of Louisiana.
- 5. LRTA supports state revenue enhancements that provide a meaningful economic impact on retired educators in enhancing their dignity, independence and overall quality of life.
- LRTA supports funding from state funds to offset increasing costs of health insurance premiums and other benefits for retired educators offered by the Office of Group Benefits and other health care insurers and providers.
- 7. LRTA opposes any action that would negatively impact

- the actuarial soundness of the Teachers' Retirement System of Louisiana.
- 8. LRTA opposes the consolidation of the Teachers' Retirement System of Louisiana with any other retirement system.
- LRTA opposes the consolidation of assets of the Teachers' Retirement System of Louisiana with any other retirement system, and opposes any other action that would dilute membership control of the investment of the assets of the Teachers' Retirement System of Louisiana.
- 10. LRTA opposes any action that would alter the current defined benefit structure offered by the Teachers' Retirement System of Louisiana to its members.
- 11. LRTA opposes the provision of state funded scholarships/vouchers for public elementary and secondary school students to attend private and non-public schools, and supports a viable public education program that requires educators to become members of the Teachers' Retirement System of Louisiana.
- 12. LRTA supports repeal of the Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP) of the Social Security Administration and opposes mandatory Social Security coverage of public employees in Louisiana.

Protect yourself this flu season

There are two different types of flu vaccinations this year, the H1N1 (swine) flu vaccine and the seasonal flu vaccine. Both are covered by all OGB health plans.

The Centers for Disease Control and Prevention (CDC) recommends getting vaccinated for both types, although people age 65 and older are not at high risk of getting H1N1 (swine) flu. Seniors are not in the initial target groups for vaccination, but can get vaccinated when supplies become available.

According to the CDC, the best ways

to help protect yourself and your family this flu season are to:

- get vaccinated;
- avoid touching your eyes, nose and mouth;
- wash your hands often;
- avoid close contact with people who are sick; and
- stay home if you are sick.

Effective September 30, 2009, flu vaccinations administered at pharmacies are covered by OGB's PPO, EPO, HMO and Medical Home HMO plans. Claims are processed subject to the

appropriate co-payment and deductible for each plan. Instructions on how to submit claims and receipts for flu vaccinations given at pharmacies can be found on the OGB website (www. groupbenefits.org) by clicking on the link to the *Health Plans* web page and then clicking on the link for the plan in which you are enrolled.

- 2) Zero out all sales taxes, property taxes and income taxes for Louisiana citizens and businesses. Income taxes would have a negative factor that would grant each individual and business a rebate rather than paying state income taxes. An individual or business would get a rebate even if they showed no taxable income. Local governments and school boards would receive 125% of the property taxes and sales taxes to which each is entitled.
- 3) Increase benefits and compensation for retired teachers, police, firemen, active teachers, and other public employees.
- 4) Improve the business structure and climate as well as provide top quality school facilities and educational programs from pre-k through college, quality hospitals, nursing homes, and facilities to improve physical and mental health.

Some immediate concerns that need our attention are:

- 1) Finding a funding vehicle for the payment of consistent cost-of-living adjustments (referred to in Act 497 as permanent benefit increases). It appears with the constraints of Act 497 and the Employee Experience Account (COLA account) being reduced from \$290 million to \$0, there will be little chance in the near future of excess interest earnings of TRSL to reach \$900,000,000 in order to pay a 3% adjustment to TRSL retirees or beneficiaries.
- 2) There is serious talk of privatizing the Preferred Provider Organization (PPO) coverage offered by the Office of Group Benefits and also a reduction of the state contribution for continued on page 7

medical insurance coverage for retirees. LRTA will vigorously oppose any attempt to endanger insurance rates and diminish insurance benefits for retirees.

- 3) There are legislative hearings now going on to change the defined benefit plan of the Teachers' Retirement System of Louisiana to a defined contribution plan for those teachers entering the system after July 1, 2010. The question you may have is how can that impact me? The answer is simply that the defined contribution plan would be similar to a 401(k) plan, and funds would not go into the TRSL assets for investment and ultimately for benefit payments to retirees. Any legislation that reduces the number of education personnel from depositing funds into TRSL will weaken TRSL. We must strongly oppose this idea.
- 4) Some have brought up the subject of the exemption from paying state income taxes on retirement benefits. If this exemption is removed, it would provide additional revenues for the state, but it would tax the benefits of retirees. We must oppose this idea if it moves forward.

There is strong consideration of further reductions in the Louisiana budget of up to \$2 billion. The drastic cuts needed to implement this magnitude of budget reductions would impact a large group of Louisiana citizens in some manner.

Promotion of the Eldridge Plan has the potential to eliminate the economic woes facing Louisiana and to be an economic boon for all the citizens and businesses of the state. In order to support the LRTA endorsement of Mr. Eldridge's Plan, retirees must pick up the mantle and walk the walk, and talk the talk, to garner a groundswell of support throughout Louisiana. This revenue proposal offers our best hope to avoid retiree benefits from being diminished or eliminated in the future.
