Harvesting Knowledge for Challenges of the 21st Century

Plans are being finalized for the 2009 Fall Meeting in Lafayette. Meeting dates are October 19, 20, and 21, at the Lafayette Holiday Inn. The Holiday Inn is located at 2032 N. E. Evangeline Thruway (Hwy. 167 just south of I-49). A special room rate of \$79 per night (\$89 for atrium rooms), plus tax, has been negotiated with the Holiday Inn for LRTA attendees. The deadline to receive this special rate is October 6, 2009. Individuals may make room reservations by calling the Lafayette Holiday Inn at (800) 942-4868.

The meeting will be hosted by LRTA District V. Host Committee Chair is Jerry Caillier, and Co-Chairs are Bonnie Lyons and Hazel Turner. Together, they chair a committee of District V volunteers that is working hard to make this a Fall Meeting to remember. This year's meeting theme is "Harvesting Knowledge for Challenges of the 21st Century."

Meeting activities kick off with the Executive Board Meeting, scheduled for 2:00 p.m. on Monday, October 19.

The Board meeting is open to the public.

Guests attending the Pre-Convention Dinner at 6:30 on Monday evening will be entertained by local musicians. Tuesday evening Convention Banquet attendees will be treated to the wit and wisdom of Ginger Cormier. The banquet program will conclude with presentations of the LRTA Name of Fame awards to honorees from Districts IV and VIII. Tickets for both meal functions are available by pre-reservation only.

A Membership/Advocacy Workshop will be held at 3:00 p.m. on Tuesday, October 20, after the close of the general session. This year an advocacy component has been added to what was previously called the Membership Roundtable. Membership recruitment will be discussed, as well as ideas for strengthening relationships and communication between legislators and local units / individual retirees in their home districts. From the Desk of the President

The LRTA Executive Committee and the LRTA Legislative Committee met August 12, 2009 to formulate plans for the future. It was a very productive session which covered many topics of concern for our organization and

its membership. Act 497 of 2009 was the major topic of discussion for the LRTA leaders assembled in the boardroom of the LRTA of-

Act 497 originated in the senate as Senate Bill No. 296 and was passed on the senate floor on May 28, 2009, the day we gathered on the capitol steps for the "LRTA Day at the Capitol". The bill passed the senate with no votes to spare. It took a minimum of 20 votes to pass. If one senator of the 20 would have voted "No" to SB 296, it would have failed to pass that morning. The bill passed the House Retirement Committee and then passed on the floor of the House of Representatives. Governor Bobby Jindal signed it into law on July 10, 2009. Act 497 swept all the funds (approximately \$290 million) from the Employee Experience Account to make a payment on the Initial Unfunded Accrued Liability which was created by the state not paying its share to the Teachers' Retirement System of Louisiana. The Employee Experience Account was set into place by the legislature and the governor in 1992 to provide cost-of-living adjustments for retired educators on a consistent basis.

The Employee Experience Account created by the legislature in 1992 still exists in Act 497, but it has no funds in it. ZERO!!! Our LRTA staff, LRTA officers, LRTA Executive

Committee and Legislative Committee have determined that under Act 497, there is very little likelihood that a permanent benefit increase will be forthcoming in the foreseeable future. In Act 497, the term Cost-of-Living Adjustment (COLA) was replaced by the term Permanent Benefit Increase (PBI). Under the stipulations of Act 497, in order for retirees to receive a PBI, the investments of TRSL would have to exceed 8.25% in earnings. The first \$100 million above the 8.25% earnings will reduce the Initial Unfunded Accrued Liability which is estimated to be \$7+ billion. (Note: The state is using TRSL investment earnings to pay for a liability that should be its responsibility to pay with state funds.) The second \$100 million will be used to pay down the Unfunded Accrued Liability which was created when the Employee Experience Account had a negative balance which was eliminated by the legislature and governor in 2004. This amount is approximately \$1.2 billion, and it is reasonable for TRSL surplus earnings to be used to pay on this liability.

In years when TRSL investment earnings are above 8.25% on an actuarial basis, certain conditions must be met in order for the retirement system to grant a 3% permanent benefit increase. First, the Consumer Price Index for all urban consumers (CPI-U) increase from December to December must be 3% or more. It is anticipated that a 3% permanent benefit increase for all eligible retirees will cost in the neighborhood of \$350 million. So, the retirement system's excess interest earnings will have to be at least \$900 million for sufficient funds to be available to provide that increase. The unfunded accrued liabilities will receive the first \$200 million. The remaining \$700 million will be split: \$350 to TRSL for the system's liabilities, and \$350 million to the Employee Experience Account.

Executive Director's Report

As Dr. Craft mentioned in his message, "From the Desk of the President," your LRTA officers have already begun planning and strategizing for the 2010 Regular Legislative Session. The session will begin at noon on Monday, March 29. We are anticipating that a number of issues very important to retired educators will be presented as legislation. They include: payment of future permanent benefit increases

under the provisions of Act No. 497 of 2009, discussions involving the development of a defined contribution plan for members of the state retirement systems, placing limits on boards of trustees regarding investments of the trust fund from which your retirement benefits are paid, and other issues involving the administration of that trust fund.

Senator D. A. "Butch" Gautreaux, chairman of the Senate Retirement Committee, and Representative Joel D. Robideaux, chairman of the House Retirement Committee issued a press release soon after the 2009 Regular Legislative Session indicating their interest in studying mechanisms by which future benefit increases could be financed. Dr. Craft has issued both chairmen an invitation to share their ideas with the LRTA membership at our Fall Meeting.

During the next session of the legislature, it will be extremely important for us to get in touch with you in order to keep you informed. Using traditional approaches such as the issuance of legislative updates, faxes and phone calls is helpful, but in many cases we need immediate action from our members. One way to accomplish this is to contact you through LRTA's E-Mail Club. If we do not have your current e-mail address on file, please consider joining. It's easy, and takes just a minute of your time. Instructions on how to join are provided in the box below. Also remember to check LRTA's web site. We will continue to provide legislative updates and other information on the link entitled "LRTA & the Legislature." The website address is www.lrta.net.

In the years when TRSL investment earnings are less than 8.25% but TRSL is at least 80% funded and the CPI-U is 2% or more, then a 2% PBI may be granted if there are adequate funds in the Employee Experience Account. Please note: TRSL has never been 80% funded. If the account balance is not adequate to fund the full 2% or 3% PBI, then no partial PBI will be granted. Partial increases are not allowed under this new act. Only those 60 years old or older are eligible for Permanent Benefit Increases. Prior 1992 legislation granted full or partial COLAs to retirees 55 years of age or older. Act 497 is not friendly legislation for educational retirees. It is a method for the

governor and legislature to pay down the Initial Unfunded Accrued Liability on the backs of retired teachers who did not create the liabilities. We as active teachers and school personnel paid our fair share into the Teachers' Retirement System of Louisiana, but former governors and former legislatures did not pay the state's share. For many years they made only partial contributions. The 2009 legislature and governor decided that \$290 million in the Employee Experience Account and future surplus earnings of TRSL up to \$100 million per year will be used to pay on the IUAL. LRTA will be considering revisions that can be made to Act 497 during the 2010 Regular Legislative Session to make it more palatable to retired educators.

To ensure that our collective voice is heard, plans are in place for the second LRTA Day at the Capitol on <u>April 29, 2010</u>. Also, the Legislative Contact Teams will be strengthened and expanded. New LRTA legislative priorities will be developed by the LRTA Legislative Committee. There will be a Membership/Advocacy Training Session held in conjunction with the Fall Meeting.

Information about deadlines to redeposit hurricane distributions

Did you receive funds from a DROP or ILSB distribution made under the provisions of the Katrina Emergency Tax Relief Act of 2005 (KETRA) or the Gulf Opportunity Zone Act of 2005 (GO Zone)? Would you like to redeposit them back into your TRSL account?

State law allows TRSL members who received a DROP/ILSB qualified hurricane distribution before January 1, 2007, to repay some (or all) of those funds, as long as it is done within three years from the date the funds were received. For example, if you received a hurricane distribution in September 2006, your deadline to repay all or a portion of those funds would be September 2009.

To make a repayment, please submit the following form and your check to TRSL within three years of the date of your distribution: *DROP or ILSB Qualified Katrina Emergency Tax Relief Act of 2005 (KETRA) or Gulf Opportunity Zone Act of 2005 (GO Zone) Withdrawals Repayment* (Form 11-RD).

This form can be found on our website, www.trsl.org. For federal reporting requirements, please refer to IRS Form 8915. It can be found at the IRS website, www.irs.gov.
