LRTA Spring Meeting April 13 and 14

LRTA and Host District VII invite all Louisiana retirees to join them for the 2010 Spring Meeting in Alexandria on April 13 and 14. District President James Stewart and his host committee promise to generate lots of fun around the theme "Let's Make a Deal!" Be sure to attend the meeting meal functions to get in on the wheeling and dealing!

The Executive Board meeting, which is open to the public, will be held at 2:00 p.m. on April 13. A pre-convention dinner will be held on the evening of April 13. Meeting general sessions will begin at 9:00 a.m. on Wednesday April 14. A representative from the Office of Social Security, whose presentation will focus on Government Pension Offset and Windfall Elimination Provisions (GPO/WEP), will be one of the featured speakers.

Reports and updates will be given by the Teachers' Retirement System of Louisiana, the Office of Group Benefits, and the LRTA Foundation. LRTA Membership Awards for 2009 will also be presented. Just prior to the conclusion of the general session, a memorial service will be led by LRTA Second Vice-President Felix Johnson, Jr. The meeting will conclude with a mid-day luncheon at which honorees from Districts V, VI and VII will be inducted as Name of Fame award winners. Finally, at the close of the luncheon, new LRTA officers will be installed.

All meeting and meal functions will be held at the Alexander Fulton Hotel and Convention Centre, 701 Fourth Street in Alexandria. There is no cost to attend meeting sessions; meal function costs are \$24 for the pre-convention dinner on April 13 and \$20 for the luncheon on April 14.

Hotel reservations should be made directly with the Alexander Fulton Hotel and Convention Centre, (318) 442-9000. A special LRTA convention room rate is provided at \$70 per

night, plus tax, for reservations made before March 26, unless the hotel sells out before that date.

In order to eliminate long lines at registration, please pre-register by completing the Meeting Pre-Registration Form on page 8. Convention packets containing programs, name tags and other important meeting materials will be prepared for participants who pre-register by April 5.

From the Desk of the President

My two year tenure as your LRTA president will end April 14, 2010 when a new president is sworn into office at the upcoming Spring Meeting. It has been my great pleasure, and privilege, to have had the opportunity to serve the membership

and the association as president. It has also been rewarding to me to serve with the Executive Committee, the Executive Board, and all other LRTA committees that have been busy going about the work of the association. I have had the opportunity to visit with members and to address many of the Units and Districts. Carolon and I have made many new friends along the way.

My first experience in service to LRTA was five years on the Executive Board representing District I as its president. After that, I was elected to a two-year term as first vice-president of LRTA and then to a two-year term as president. I will continue to serve on the Executive Committee and Executive Board for a two-year term as immediate past president.

During the last four years, one of my top priorities has been membership development, and I will continue to assist LRTA's first vice-president in that endeavor. Membership drives the vehicle called LRTA. It is imperative that we build a bigger LRTA by promoting membership involvement from grassroots to the state capitol. Retired education personnel have the influence, the clout, and the power to impact Louisiana in many positive ways. Now is the time to make that evident.

LRTA membership must be on the defensive and show a united front in opposing legislation that is not in the best interest of retired educators. At the end of 2008, LRTA membership had grown to its highest point in its history with well

Executive Director's Report

The 2010 Regular Legislative Session begins at noon on Monday, March 29. I am already aware of legislation that may be introduced which could impact you as a retired educator, or have a potential impact on your retirement system. Under

the provisions of the Louisiana Constitution, the intention to introduce retirement legislation must be advertised thirty days prior to the introduction of the legislation. Here is a list of some of the topics advertised for consideration by the legislature.

 Consolidation of the four state retirement systems—these four retirement systems are: Teachers' Retirement System of Louisiana, Louisiana State Employees' Retirement System, Louisiana School Em-

- ployees Retirement System and State Police Pension and Retirement System
- Implementation of a defined contribution retirement plan for new employees hired on or after July 1, 2010
- Provisions governing Permanent Benefit Increases (formerly known as COLAs) for state retirement systems
- Elimination of the Deferred Retirement Option Plan for all state retirement systems
- Elimination of, or adjustments to, the retiree return-to-work provisions for teachers.

Other legislation designed to lower the cost of providing a defined benefit retirement plan may be considered. This list includes:

- Using the highest 60 consecutive months of salary, instead of the highest 36 consecutive months, to compute retirement benefits
- Limiting increases in salary that can be used for retirement benefit calculations

2010 Legislative Priorities

LRTA supports legislation that will positively affect retired teachers and opposes legislation that will adversely affect retired teachers. LRTA also supports efforts to maintain adequate funding for top quality public education in Louisiana. Although these priorities are listed in numerical order, the items listed are all top priorities of LRTA.

- LRTA supports a viable Employee Experience Account for accumulating a portion of the excess interest earnings of the Teachers' Retirement System of Louisiana for future funding of permanent benefit increases (PBIs) for retirees.
- 2. LRTA supports dedicated allocations from state funds for permanent benefit increases.
- LRTA supports a stable, automatic permanent benefit increase provision for retirees as part of the benefit structure offered by the Teachers' Retirement System of Louisiana.
- LRTA supports dedicated allocations from state funds to meet the state's obligation to reduce the Initial Unfunded Accrued Liabilities (IUALs) of the Teachers' Retirement System of Louisiana.
- LRTA supports state revenue enhancements that provide a meaningful economic impact on retired educators in enhancing their dignity, independence and overall quality of life.
- LRTA supports funding from state funds to offset increasing costs of health insurance premiums and other benefits for retired educators offered by the Office of Group Benefits and other health care insurers and providers.

- 7. LRTA opposes any action that would negatively impact the actuarial soundness of the Teachers' Retirement System of Louisiana.
- 8. LRTA opposes the consolidation of the Teachers' Retirement System of Louisiana with any other retirement system.
- 9. LRTA opposes the consolidation of assets of the Teachers' Retirement System of Louisiana with any other retirement system, and opposes any other action that would dilute membership control of the investment of the assets of the Teachers' Retirement System of Louisiana.
- 10. LRTA opposes any action that would alter the current defined benefit structure offered by the Teachers' Retirement System of Louisiana to its members.
- 11. LRTA opposes the provision of state funded scholarships/vouchers for public elementary and secondary school students to attend private and non-public schools, and supports a viable public education program that requires educators to become members of the Teachers' Retirement System of Louisiana.
- 12. LRTA supports repeal of the Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP) of the Social Security Administration and opposes mandatory Social Security coverage of public employees in Louisiana.

- Raising the retirement eligible age to 60
- Increasing the percentage of salary contributed by employees to the retirement system.

Each year LRTA adopts a listing of legislative priorities. The 2010 priorities are printed above, and address many of the topics listed. One very important issue is the creation of a defined contribution plan for newly hired educators—a plan that would go into effect

July 1, 2010. This is a very complex issue, and my limited space here does not permit me to explain differences between defined contribution and defined benefit retirement plans. However, Dr. Craft's recent letter to the editor, which many of you saw printed in your local newspaper, and a complete explanation of the plan differences are provided under the LRTA & the Legislature section on the LRTA web site: www.lrta.net.

As always, the LRTA staff will be providing periodic updates throughout the session regarding these and other matters. The easiest way for you to receive this information is to join the LRTA E-Mail Club, and instructions on how to join that club are provided. Staying in touch with your staff and your legislators is of key importance during this time. Please take a few minutes to let members of your legislative delegation know how you feel regarding legislation mentioned above.

A complete update on all legislative matters will be provided at the LRTA Spring Meeting. A registration form is included on the back page, and I hope to see many of you there.

over 20,000 members. I asked Dr. John Foster to serve as the Associate Member Development Czar for LRTA. He trained retirees to visit schools around the state to solicit associate members from the ranks of active teachers. He traversed the state speaking to school faculties and recruiting associate members. As a result of his dedicated efforts, associate membership increased to over 2000. We must keep this drive alive. All active teachers will retire at some point in time, and until then, they need to be convinced that becoming an associate member of LRTA is the appropriate thing for them to do.

At the LRTA Fall Meeting in 2007, the LRTA Executive Board adopted a strategic plan to guide the association into the future. I am happy to report that the major goals set forth in that plan have all been achieved including the consolidation of the LRTA Constitution and By-laws.

Some other notable milestones:

Under the leadership of Mr. Benjamin Sandifer, chairperson of the Legislative Committee, the Executive Board expanded and clarified LRTA's legislative priorities. The priorities include many issues important to retired educators as well as seeking the repeal of the unfair federal statutes dealing with the Government Pension Offset (GPO) and the Windfall Elimination Provision

(WEP). The Executive Board passed a resolution advocating repeal of GPO and WEP. It was sent to the President of the United States and to the Louisiana congressional delegation. We must continue the fight to repeal these unfair federal statutes that negatively impact so many LRTA members.

The LRTA Executive Committee and LRTA Executive Board supported a resolution endorsing the LA Self-Help Plan created by Mr. J. Ronald Eldridge. This plan would impose an excise tax on pipelines which would be paid by 98.25% of individuals and businesses outside of Louisiana. It would tax gasoline going through the pipelines at the rate of 25 cents per gallon and natural gas at less than 3 cents per cubic foot. Revenues generated from this excise tax would build back the barrier islands and the Louisiana coastline to its condition that existed in 1900 prior to pipeline intrusion along our shores. It would also provide adequate revenues to zero out sales, income and property taxes for individuals and businesses in Louisiana. It would provide funds to eliminate the unfunded accrued liabilities of state retirement systems as well as provide for an increase of \$3,000 per month for retired teachers. It would be a financial boon for Louisiana thus eliminating the financial woes that exist today. I need your help in creating awareness of the Louisiana Self-Help

Plan. For our children's and grandchildren's sake, let us push forward on this plan. It will benefit all of us.

With the expansion of the LRTA website, members can find important information on legislation, locate the members on the House and Senate retirement committees, the LRTA position on bills being considered during a legislative session, how legislators voted on key bills, and other topics regarding LRTA membership. Information is provided about the LRTA Spring and Fall Meetings, and important links are included. The LRTA Foundation now has its own designated area on the site. Take some time to familiarize yourself with the information supplied at your fingertips.

The LRTA E-Mail Club gives members an opportunity to receive accurate and timely information on legislation. Belonging to the club allows members to be proactive and contact their legislators timely relative to their pending consideration of a bill. If you have not done so, send your e-mail address to info@lrta.net and join the E-Mail Club. You will then receive the latest communications from the office in Baton Rouge regarding legislation and other matters.

During my term, I began utilizing news releases and letters to the editor as tools to explain LRTA's positions on issues.
