Strategies have been set in place for all members to get involved in extending invitations for non-members to become part of the Louisiana Retired Teachers Association.

As of October 20, 2010, the membership statistics indicated that the rankings of the top five districts were:

District X with 39.2%, Districts I and II tied with 38.4% each, District XI with 37.5%, District V with 36.8% and District VIII with 35.6%.

The top ten parishes in percent of membership were:

Assumption with 60.8%, St. James with 58.1%, Cameron with 56.7%,

## From the Desk of the President

I begin with holiday greetings to each of you. When you receive this we will be rapidly approaching Christmas and the New Year. From all of us at LRTA, may all of your holidays be filled with the blessings of family and friends. May all of us make this a time of renewal and re-dedication.

We had a very successful Fall Meeting in October. Attendance was good, and members reported that they found the sessions meaningful and relevant. I thank all of the members in northeast Louisiana for the splendid planning and hosting. We were truly blessed by our time in Monroe. We completed our leadership training workshop in mid-November and had excellent participation, representation, and feedback relative to this biennial event. District leaders expressed their belief that they could use the ideas and skills presented during the session to more effectively organize and unify local membership groups.

We continue to face challenges to the control of our assets at the Teachers' Retirement System of Louisiana. We now find that while we were busy trying to stop the consolidation of the retirement systems, a bill giving the legislature greater control over when we could get *any* increase in benefits "sneaked" through the House and Senate and was passed by the people as Amendment 6 at the last statewide election. We have analyzed the Amendment and checked with legal counsel in government and find that no increase which would have an actuarial impact (they all do) could be given without a 2/3 vote of both houses of the Legislature. With the recession now officially over and inflation an inherent by-product of this cycle, we retirees will be taking another economic hit.

What can we do? The executive committee and executive director will be meeting with other retirement community representatives similarly affected. We will look for ways to work around this new development, but have no ready answers at the moment. What does this mean to you? First, each of the approximately 54,000 retirees who receive checks from TRSL must become members of LRTA if we are to succeed in protecting our assets. At present, approximately 20,000 members are carrying the load of

## Executive Director's Report

The LRTA state officers and staff hosted an LRTA Leadership Training Workshop in Baton Rouge on Tuesday, November 16. The purpose of the workshop was to develop interest among LRTA members in considering the acceptance of leadership positions in the association. Those invited to attend were the current LRTA District presidents, and they had the opportunity to invite their District's first vice-presidents and two other individuals who were emerging in their respective areas as potential LRTA leaders. Forty-two people attended, including the district presidents, first vice-presidents, some unit presidents, and others who expressed an interest in attending.

A full agenda was discussed. The officers had an opportunity to share with the attendees the duties and responsibilities associated with their respective state-wide elective offices. The staff reviewed LRTA's Articles of Incorporation, Bylaws, the *LRTA Board Policy and Employee Handbook*, the association's code of ethics, and the LRTA Strategic Plan. After lunch, the attendees were provided information on LRTA membership and member recruitment, and also received training on district operations and meeting and program planning. The day's agenda ended with a discussion on LRTA's interface with the Louisiana Legislature, and a time for questions and answers.

Future leadership training workshops will be held each Fall after the installation of the newly elected LRTA President. From comments, and other indications, those attending felt their time was well spent in Baton Rouge.

### What Happened to My Check Stub?

TRSL has changed the frequency at which direct deposit payment stubs are mailed, saving the retirement system approximately \$100,000 each year. Payment stubs are now mailed only when one of the following occurs:

- You set up direct deposit for the first time.
- There's a change in your net pay.
- The calendar year ends.

## An Inside Look – Office of Group Benefits

As required by the U.S. Department of Health and Human Services, all OGB plan members will soon receive a letter about OGB's participation in the Early Retiree Reinsurance Program (ERRP).

Authorized by the federal Affordable Care Act (ACA), the health care reform legislation passed by Congress earlier this year, ERRP is an incentive program for employers that provide health coverage to early retirees (ages 55 to 64) who are not yet covered by Medicare. Effective June 2010, OGB

and other qualifying employers can request federal reimbursements for 80 percent of health care claim payments on behalf of early retirees that total between \$15,000 and \$90,000 per year.

OGB expects to receive between \$64 million and \$74 million annually through 2013 (when the program expires) or the \$5 billion appropriated for the program is exhausted. Health care costs continue to rise each year, so OGB will use ERRP claim reimbursements to offset these cost increases, which will

help OGB keep your health care plan **premiums** as low as possible.

Morehouse with 56.1%, Claiborne with 46.5%, Desoto with 45.9%, Lafourche with 44.9%, Jackson with 42.9%, LaSalle with 42.9% and Winn with 42.7%.

District presidents are urged to work with their unit presidents to increase membership across the board in RTA units and LRTA. LRTA members are automatically members of their district; however, local unit membership does not automatically provide for membership in the district and state. All leaders should clarify this confusion by encouraging everyone to join their local unit and also the state LRTA!

Plans are underway to further expand LRTA associate membership of active educational personnel in the public schools of Louisiana. This is an effort to increase awareness and support of public education needs and retirement concerns. Working with local superintendents, plans are in place for payroll deductions of \$10.00 annual dues on

April 1 each year. This will continue in force until the active school employee retires and becomes a full-fledged retiree member of LRTA.

Dr. John Foster, past LRTA president, has developed a DVD presentation which will be utilized in public schools in parishes with approved payroll deductions for LRTA associate member dues. This will provide ongoing membership in LRTA for the future. Increased membership will provide a greater degree of lobbying potential in the Louisiana legislature as well as the Congress of the United States relative to Windfall Elimination Provision and the Government Pension Offset.

Let us continue united efforts to have every District in LRTA exceed the 50% point of membership. Your efforts to help reach this goal are commendable. Your ideas are welcomed in promoting LRTA.

In October of 2009, the LRTA Executive Board passed a resolution in support of a pipeline excise tax plan developed by J. Ron Eldridge. This could

provide necessary revenues to eliminate the unfunded accrued liability of the Teachers' Retirement System of Louisiana as well as fund substantial cost of living raises. protecting the assets of 54,000 retirees. We must have each of the remaining 34,000 retirees fill out the form allowing a \$25.00 deduction annually in April. The challenge to our economic security is grave and ongoing. We will not be fully successful until every retiree becomes part of the solution.

Secondly, we must become politically active. Each retiree must have the name, phone number, and e-mail address of her/his senator and representative. We need you to join the LRTA e-mail service so that we may get needed information to you quickly, especially during legislative sessions. We must ensure that each member of the legislature has at least two LRTA representatives who will monitor his/her actions relative to retirement issues. This will work best if these persons have taught the legislator, knows him/her socially, or has some other one-on-one relationship with him/her. For those members who do not use computers, we need letter and telephone trees established to protect and advance our interests.

Thirdly, we need to dedicate ourselves to mutual support in 2011. As we mature, we need to establish an active social network. This is especially true for each local unit. Break-

fast clubs, lunch clubs, tour groups, card games, "staycations" and regular conversations can strengthen support all year long, not just when we need to mobilize as a well-tuned team to address legislative matters.

I am enjoying meeting with groups throughout the state. The most gratifying aspect of my job as president is meeting with members in their home areas. My greatest challenge is to forge LRTA into a force that cannot be ignored by the legislature, treasurer, or governor. We must become one force dedicated to "making retirement years great."

Please make one of your New Year's resolutions to become more active in this organization. We need your contributions of time, talent, and membership. Without a well-tuned organization of highly intelligent members, we will be marginalized and ignored. With all TRSL retirees active, supporting one another, we will turn the tide in our favor and become a force that cannot be ignored. Let's all have a successful Happy New Year!

## AARP/NRTA Community Service Award

Nomination forms are now being accepted for the 2011 Annual Chapter & REA Unit Community Service Award. This annual award is given on behalf of AARP/NRTA and the chapter/Retired Educators Association (REA) unit to the person providing the most outstanding service to the community through a unit- or chapter-sponsored service project in 2010. The award (a commemorative certificate and pin) will be mailed in time for presentation during National Volunteer Week in April. **Providing this information is the direct responsibility of the current-year (2010) chapter or REA/RTA unit president.**

The Board of Directors of the chapter or REA/RTA unit selects one individual (or couple) whose name(s) will appear on the award certificate. In selecting the recipient, the Board should invite recommendations from the chapter or unit membership.

An Important Note About Eligibility for this Award – The individual(s) recognized with this award must be a member of the chapter or unit, and the activity for which they are being considered must be a chapter- or unit-sponsored activity. This means the chapter or REA/RTA unit Board must have endorsed the activity as an official chapter/unit service program. **Note: Groups or Committees are not eligible for this award.**

**This award should not be confused with AARP's Andrus Award for Community Service**, which is presented annually by AARP for outstanding service *in each state*.

**If your unit wishes to make a nomination for this award, contact the LRTA office to request a nomination form. Hurry, all forms are due to the AARP office in Washington on or before January 31, 2011.**
