AMBA Contract Renewed by Executive Board

The LRTA Membership Committee met on September 9, 2011 to consider the renewal of the association endorsement agreement between LRTA and Association Member Benefits Advisors (AMBA). The committee engaged in full discussion about the existing agreement and considered a number of amendments to that agreement. The amendments dealt mainly with clarifying language and the extension of the agreement. The committee provided its recommendations to the LRTA Executive Board at the recently held Fall Meeting.

On October 24, 2011, the Executive Board approved the agreement with the negotiated changes recommended by the Membership Committee. I am happy to inform the membership that LRTA and AMBA

have entered into a new agreement for the endorsement of AMBA offerings for the next five years. The new agreement was implemented on October 25, 2011 and runs through October 24, 2016.

Over the past five years, AMBA has been instrumental in assisting LRTA with the recruitment of regular and associate members. I, along with your other LRTA officers, look forward to working with AMBA representatives in the future to help grow the LRTA membership roll. 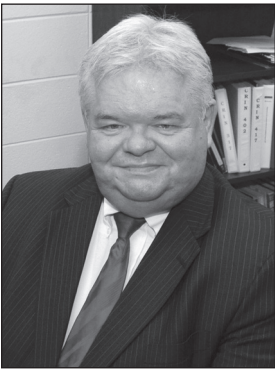

Executive Director's Report

Based upon attendance at the 2011 LRTA Fall Meeting, it can be said that our conference was a huge success. Nearly 300 LRTA members, their spouses and friends met in Kenner, Louisiana for the event, a record attendance for any Spring or Fall Meeting in recent years. Maria Sly George, District I president, and her planning committee, which included representatives from LRTA District II, had every detail taken care of before our arrival at the Airport Hilton. Their hard work was greatly appreciated by all who attended.

One of the major themes of the general sessions was retiree benefits and how they may be impacted in the future. Ms. Dara Dann, senior legislative representative of the National Retired Teachers Association (NRTA), spoke about initiatives being discussed by the U. S. Congress regarding Social Security and Medicare. She also provided an update on trends affecting public pension plans throughout the nation. I followed Dara with an update on the 2011 Regular Legislative Session, and provided information on what LRTA anticipates for the upcoming session of the legislature.

Your officers and staff will be closely monitoring any developments on the consolidation of your retire-

ment system with other state retirement systems, the change of governance of the TRSL board of trustees, efforts to create a defined contribution retirement plan for new employees, and the privatization or sale of the Office of Group Benefits. On behalf of the membership, LRTA will oppose any legislation or effort regarding these topics. The LRTA Legislative Committee recommended, and the Executive Board approved allowing the officers and staff to seek reintroduction of a bill dealing with the provision of future permanent benefit increases (PBIs), which were formerly referred to as COLAs.

Ms. Maureen Westgard, director of the Teachers' Retirement System of Louisiana, and Mr. Malcolm Veazie, administrator of the Customer Services Division of the Office of Group Benefits, provided updates on their agencies. With these presentations, attendees of the Fall Meeting were provided the latest information on their pension and insurance plans.

The LRTA staff has negotiated a contract with the Baymont Inn and Suites/Sai Convention Center in Alexandria for the 2012 Spring Meeting. The hotel and convention center is located at 2301 North MacArthur Drive, and the dates reserved for our meetings are April 24 and 25, 2012. It is not too early to note the change of location and the dates on your calendar. Plan to attend so that we can have another record breaking attendance.

Ann, Renee and I wish you, your families and friends a happy holiday season, and a great beginning to 2012.

2012 Legislative Priorities

LRTA supports legislation that will positively affect retired teachers and opposes legislation that will adversely affect retired teachers. LRTA also supports efforts to maintain adequate funding for top quality public education in Louisiana. Although these priorities are listed in numerical order, the items listed are all top priorities of LRTA.

1. LRTA supports a viable Employee Experience Account for accumulating a portion of the excess interest earnings of the Teachers' Retirement System of Louisiana for future funding of cost-of-living increases for retirees.
2. LRTA supports dedicated allocations from state funds for cost-of-living increases.
3. LRTA supports a stable, automatic cost-of-living increase provision for retirees as part of the benefit structure offered by the Teachers' Retirement System of Louisiana.
4. LRTA supports dedicated allocations from state funds to meet the state's obligation to reduce the Initial Unfunded Accrued Liabilities (IUALs) of the Teachers' Retirement System of Louisiana without causing an adverse budget impact on public education agencies or retirees.
5. LRTA supports state revenue enhancements that provide a meaningful economic impact on retired educators in enhancing their dignity, independence and overall quality of life.
6. LRTA supports funding from state funds to offset increasing costs of health insurance premiums and other benefits for retired educators offered by the Office of Group Benefits and other health care insurers and providers.
7. LRTA opposes any action that would negatively impact the actuarial soundness of the Teachers' Retirement System of Louisiana.
8. LRTA opposes the consolidation of the Teachers' Retirement System of Louisiana with any other retirement system.
9. LRTA opposes the consolidation of assets of the Teachers' Retirement System of Louisiana with any other retirement system, and opposes any other action that would dilute membership control of the investment of the assets of the Teachers' Retirement System of Louisiana.
10. LRTA opposes any action that would alter the current defined benefit structure offered by the Teachers' Retirement System of Louisiana to its members.
11. LRTA opposes the provision of state funded scholarships/vouchers for public elementary and secondary school students to attend private and non-public schools, and supports a viable public education program that requires educators to become members of the Teachers' Retirement System of Louisiana.
12. LRTA supports repeal of the Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP) of the Social Security Administration and opposes mandatory Social Security coverage of public employees in Louisiana.

AARP/NRTA Community Service Award

Nomination forms are now being accepted for the 2011 Annual Chapter & REA Unit Community Service Award. This annual award is given on behalf of AARP/NRTA and the Retired Teachers Association (RTA) unit to the person providing the most outstanding service to the community through a unit-sponsored service project in 2011. The award (a commemorative certificate and pin) will be mailed in time for presentation during National Volunteer Week in April. **Providing this information is the direct responsibility of the current-year (2011) RTA unit president.**

The Board of Directors of the RTA unit selects one individual (or couple) whose name(s) will appear on the award certificate. In selecting the recipient, the Board should invite recommendations from the unit membership.

An important note about eligibility for this award—the individual(s) recognized with this award must be a member(s) of the unit, and the activity for which they are being considered must be a unit-sponsored activity. This means the RTA unit Board must have endorsed the activity as an official unit service program. **Note: Groups or Committees are not eligible for this award.**

This award should not be confused with AARP's Andrus Award for Community Service, which is presented annually by AARP for outstanding service *in each state*.

Most retirees have their TRSL retirement benefits deposited directly into their banking accounts. If you have changed banks recently or intend to do so, make sure you send TRSL a new *Direct Deposit of Benefits* (Form 15D) that reflects the information of your new financial institution.

This form is available at www.trsl.org. You can also request a copy by phone at 225-925-6446 or toll free (outside the Baton Rouge area) at 1-877-275-8775, or E-mail us at web.master@trsl.org.

NOTE: Retirees who have their DROP or ILSB withdrawals directly deposited in their banking accounts should submit a new Direct Deposit of DROP or ILSB Account Withdrawals (Form 11R) with the information of their new financial institution as well.

Remember to completely fill out these form(s), including all signatures. Both you and representative from your new financial institution must sign the direct deposit form(s).
