14 Good Reasons Why You Should Join LRTA and Your Local LRTA Unit

LRTA:

1. Represents the interests of Louisiana's retired education community on proposals considered by the TRSL board of trustees, by the Louisiana legislature, and by the U.S. Congress.

2. Supports annual permanent benefit increases (PBIs) for eligible benefit recipients.

3. Will continue to work with legislative leaders and committees to increase the level of benefits for oldest retirees and to review methods for granting future PBIs from the Employee Experience Account.

4. Is working toward obtaining legislative appropriations to pay down the IUAL.

5. Supports appropriate levels of health insurance coverage for retirees through the Office of Group Benefits and local school boards.

6. Provides current information about LRTA on www.lrta.net.

7. Provides six newsletters mailed to all members each year.

8. Supports repeal of Social Security Administration benefit offsets known as GPO and WEP.

9. Opposes changes in the current governance, administrative, and benefit structure of TRSL.

10. Opposes mandatory Social Security coverage of Louisiana's actively employed educators.

11. Maintains a staffed state office to coordinate state activities.

12. Works with district and local units to provide programs and information.

13. Provides a member benefits package through Association Member Benefits Advisors.

14. There is no other association that works exclusively for Louisiana's retired education community.

All of us are hoping the sessions will provide valuable tools for communicating your thoughts and concerns to our representatives and senators.

When you are finished reading this issue, please don't put it aside. Complete your membership application and mail it back to the LRTA office as soon as you complete it. I encourage all of you to select the LRTA Dues Deduction Authorization option. This will allow TRSL to deduct your dues from your retirement check, which the retirement system will do once each year in April. Don't let it get lost in the stack on your desk like I sometimes do with important papers. The new LRTA membership year begins on April 1, 2013, so it is important that you join or renew before that date.

Mail it back to the LRTA office before the deadline at the close of business (4:30 p.m.) on Friday, February 15, 2013. Late ballots will not be counted.

The new year also means that the LRTA officers and staff will begin gearing up for the next Regular Legislative Session. The 2013 session begins on Monday, April 8

at 12:00 noon. Legislators must complete their work by 6:00 p.m. on Thursday, June 6. This year, the legislature will concentrate on revenue and expenditure issues. However, each legislator may introduce five pieces of legislation dealing with specific areas of law, and I anticipate there will be some bills dealing with retirement issues that will be included on the docket. In order to better prepare for April, LRTA is holding advocacy training workshops in each of the eleven LRTA districts. More information about those workshops is covered elsewhere in this issue.

I want to thank all of you in advance for continuing your membership in LRTA, and to invite all non-members to seriously consider joining LRTA. The association was established in 1956 and is the "voice" of the retired education community. LRTA represents the interests of all retired educators by monitoring, protecting and improving the benefits needed to secure dignity, independence, and overall quality of life. The association has now been watching out for your best interests for $5\overline{7}$ years, a legacy which we all hope to carry far into the future.

TRSL Summary annual report available online at www.trsl.org

In keeping with its commitment to provide exceptional customer service through technology, TRSL is making its summary annual report, also known as the Popular Annual Financial Report (PAFR), for fiscal year ended June 30, 2012, available to members exclusively online at www.trsl.org. TRSL joins an increasing number of businesses and government agencies that are working toward making information available solely through paperless channels.

The PAFR provides an overview of TRSL's financial condition and investment performance for Fiscal Year 2012, and highlights other important information relating to the System. Both the PAFR and TRSL's more detailed, Comprehensive Annual Financial Report (CAFR), are available on our website, www.trsl.org.

DROP accounts to earn interest for Fiscal Year 2012

TRSL DROP participants who were eligible to participate in the Deferred Retirement Option Plan (DROP) before January 1, 2004, will earn 4.55 percent interest (if eligible) this year on their DROP accounts, pending adoption of TRSL's actuarial valuation report by the Public Retirement Systems' Actuarial Committee (PRSAC). The interest rate on these DROP accounts is calculated using TRSL's actuarial rate of return, less a 0.50 percent administrative fee.

NOTE: PRSAC typically meets in January or February. At the time this newsletter went to press, the committee had not yet met to consider adoption of TRSL's valuation report.

DROP accounts for members who were eligible to participate on or after January 1, 2004, earn interest at the liquid asset money market rate of return, which averaged .0001 percent for Fiscal Year 2012. This interest is posted monthly.

As you know, the Office of Group Benefits transferred the administration of the PPO plan to Blue Cross and Blue Shield of Louisiana on January 1, 2013. As a result, OGB's 7 field offices around the state were closed as part of the reorganization plan to streamline the agency's operations.

The remaining employees at OGB headquarters in Baton Rouge will continue to oversee all OGB health coverage and life insurance, including all self-insured health plans and fully-insured HMO plans and Medicare Advantage HMO plans.
