# **LRTA Foundation Update**

The Louisiana Retired Teachers Association Foundation board of directors met Monday, October 21, 2013 10:00 a.m. at the Hilton Garden Inn in Bossier City, Louisiana to conduct the business of the organization. Treasurer Mary Ann Edwards reported that the LRTA Foundation had restricted funds in certificates of deposit amounting to \$65,729.00 and \$15,445.73 in an interest-bearing checking account. Total assests are \$81,174.73. Our goal is to reach \$100,000 in assets. Once that goal is reached, the board of directors will begin to develop a list of programs and projects to support through your many donations that have built the trust fund to the desired level.

The second LRTA Foundation Silent Auction received \$1,714.00 from the purchase of 56 donated items and two donations of \$200.00 and \$100.00 bringing the total proceeds to \$2,014.00 for the Fall Meeting. erything was planned to perfection. There was something of interest for every retired educator who attended. We received reports from several LRTA committees during the Executive Board meeting on the first day. The Nominating Committee placed into nomination the persons who expressed an interest in being a candidate for statewide office of our organization. The candidates are, for president: Maria Sly George and James T. Stewart, for first vice-president: Bertha H. Breland, and for second vice-president: Dorothy W. Brown and Nancy L. Quigley. The By-laws Committee made three recommendations for changes or modifications in our LRTA By-laws. The election of officers and the recommended by-laws changes will be voted on by the LRTA membership. Ballots for the election will be mailed to you in January.

The Executive Committee presented a new Strategic Plan for review and approval by the Executive Board. LRTA's 2014 Legislative Priorities were also presented for approval. Our executive director, Graig Luscombe, presented his report which included an update on the progress of LRTA's Membership Recruitment Program. He also introduced a plan for a coalition to be formed with the Louisiana Retired State Employees Association (RSEA) to enhance our solidarity in addressing issues that relate to retirees in our state. These listed items were all approved by the Executive Board.

For the first time in my memory, there were two break-out sessions held on the afternoon of the second day of the conference proceedings. One session was designed for local LRTA unit officers and members. The second was designed for LRTA district presidents and officers. These meetings Continued on Page 5

## **Executive Director's Report**

The board of trustees of the Teachers' Retirement System of Louisiana received information regarding the FY 2012-2103 actuarial valuation of the retirement system at the board meeting held on October 8. Important data from that report affecting re-

tirees was presented by retirement system director Maureen Westgard at LRTA's Fall Meeting recently held in Bossier City. She shared some great news! Total system assets increased by \$1.3 billion as a result of TRSL's investment portfolio, and the allocation of the assets in that portfolio. The market rate of return for last fiscal year

(gross of investment fees) was 13.88%. The market rate of return is one factor used to determine the retirement system's actuarial rate of return on investments over time. Last fiscal year, the actuarial rate of return was 13.41%.

The actuarial rate of return is a very important number for all retirees. It determines the amount of interest to be deposited into DROP (Deferred Retirement Option Plan) accounts for those members who participated in the plan prior to January 1, 2004. The interest rate for these DROP accounts for last fiscal year is .5% less than the actuarial rate of return, or 12.91%. The actuarial rate of return is also used to determine whether or not TRSL can deposit funds into the Experience Account, which is the account held at TRSL for the sole purpose of providing permanent benefit increases (PBIs) to

eligible retirees. Many of you still refer to PBIs as COLAs.

As a result of the 13.41% actuarial rate of return, TRSL was able to deposit funds in the Experience Account for the first time since 2009. As of July 1, 2013, the Experience Account had on deposit \$219.7 million. Based upon current law, those funds will be available to provide benefit increases on July 1, 2014. PBIs are paid to eligible retirees based upon the percentage change of the Consumer Price Index for all Urban Consumers (CPI-U) over the calendar vear. The CPI-U is determined by the United States Department of Labor, Bureau of Labor Statistics. This agency will not announce the CPI-U change for the 2013 calendar year until February 2014.

LRTA has been monitoring the monthly changes in the CPI-U throughout the year, and it appears that the percentage increase will be somewhere between 1.3% and 1.7%. The PBI that could be granted should be somewhere in that range. However, before any increase in retirement benefits can be granted, or before DROP interest rates can be credited to an account, a number of things must happen. First, the TRSL Actuarial Valuation for FY 2012-2013 must be approved by the Public Retirement Systems Actuarial Committee. For a PBI, the second thing that must happen is for legislation to be introduced spelling out the provisions of the PBI. And thirdly, that legislation must be passed by a two-thirds vote of both the House of Representatives and the Senate of the Louisiana legislature, and then signed into law by the governor.

The 2014 Regular Session of the legislature begins on Monday, March 10 at 12 noon. LRTA will

be engaging in many discussions with members of the legislature and the TRSL board of trustees between now and then regarding the funds in the Experience Account. A number of your colleagues in the Caddo Parish Retired Teachers Association have already been successful in having a member of their legislative delegation pre-file legislation regarding the next PBI.

Our pledge is to continue sharing information about this important issue for our retirees with decision makers on the TRSL board of trustees and in the legislature, and to continue keeping you informed about the most recent developments surrounding the approval of a PBI in 2014. Please do the same with members of your legislative delegations.

were very productive in answering and/or clearing up concerns that officers had about responsibilities, membership, operations, and other matters they chose to discuss. Many said it was the best part of the entire conference and enlightened them as to the many questions they had in reference to the office they held. The feedback we received indicated a desire to continue these break-out sessions at every LRTA Spring and Fall Meeting.

The November 1, 2013 report on membership compiled by the staff indicates there are four districts (I, II, IV, and VIII) that have already met and exceeded the 5% membership increase goal that was set for LRTA by the Executive Board back in April. Four Districts (III, VI, IX, and XI) and the "Out of State" membership category have exceeded their membership totals from the previous year. We currently have 22,905 members, and our 5% membership increase goal would raise our total membership to 23,858. So, we currently lack 953 new members to reach the goal we set for this year. We are encouraged by the growth through October, and I believe our goal can be reached by March 31, 2014 with our new membership campaign which begins in January. Mrs. George and I want to thank each of you who have worked so hard up to this point, and we encourage you to continue to work on enlisting new members. Our retirees must join together to become the catalyst for continued support of issues so important to our future.

The vast majority of LRTA operating funds is derived from membership

dues. Your dues provides the necessary support to allow your LRTA representatives to be on the front lines when issues of importance need attention in the legislature or in other venues on the state and national levels. These funds are spent wisely in accordance with a budget that is submitted by LRTA's Budget Committee to the Executive Committee for review, and then to the Executive Board for approval at the LRTA Spring Meeting each year.

One of the changes to the LRTA Bylaws adopted by the Executive Board to be voted on by the membership in January is a requirement that each of the eleven LRTA districts have a current version of its by-laws on file at the LRTA office for security and future reference. There have been some extenuating circumstances in some districts where by-laws had not been filed in a secure place and could not be located. We have asked each district president to elect or appoint a by-laws committee to review current by-laws and update them, or write new by-laws. A model set of by-laws was approved by the LRTA By-Laws Committee that contained the minimum requirements for district by-laws. This model was distributed and discussed at the district break-out session held at the Fall Meeting. After the membership in an LRTA district has adopted the new or updated by-laws, the district president will provide a copy of the document for safe-keeping at the

LRTA office. This would also be an excellent time for each local unit to follow the same process. Although it is not necessary to forward the revised unit by-laws to the LRTA office, you may do so to insure there is a copy that could be made available for future reference. All district and unit presidents should place a copy of the by-laws in their LRTA Resource Books that were provided to them at the beginning of the year.

All of the initiatives we have recently undertaken are for the distinct purpose of helping our organization become more organized in our efforts to serve our members through strength, leadership, communication, purpose, resolve. They are setting the tone and direction of LRTA making the association better equipped to protect and guarantee our rights and liberties that we have earned and deserve. Thanks to each of you for your part in this journey. We cannot let down our guard, but must stay diligent in our efforts.
