Membership is Serious Business

As we face the challenges for the future, it is imperative that LRTA has bold, strong and determined membership. Many states are attempting to balance shortfalls in their budgets on the backs of educational people and other public servants. As you probably are aware, Governor Jindal has plans to sell or privatize the PPO of the Office of Group Benefits. If Governor Jindal is successful in this effort, then the sale or transfer of the PPO will become a reality. The PPO currently has 250,000 policyholders with a surplus of over one-half billion in unspent premium dollars. The proposed sale or transfer would net approximately one billion dollars, which coupled with

up things of greater value. We are hearing those in power ask everyone to share the burden in these times of economic crisis. What lesser-value ideology should we ask them to give up for the greater good of all our citizens?

On behalf of the retired teachers, my answer to them is that we are sharing more than our rightful portion of the economic burden. We have gone three years without a costof-living increase. We paid our proportional share into the retirement system for the 30 or so years that we were in active practice. We worked long hours to do our jobs professionally with humanity, justice, and excellence. Our member representatives on the Board of Trustees have managed the TRSL with prudence and foresight since 1937. Legislators must not ask our retired members, or active members, to take an even larger share of the burden so we can give more tax breaks to the favored few, primarily out-of-state interests, and continue to have concerns about the unfunded accrued liability of TRSL.

UPDATE - Teachers' Retirement System of Louisiana

Deferred Retirement Option Plan (DROP) Interest Rates

The Public Retirement Systems' Actuarial Committee (PRSAC) recently approved TRSL's actuarial valuation report for fiscal year 2009-10. The report includes TRSL's actuarial rate of return which was -0.89 percent.

The actuarial rate of return Don't forget! If you are a disability January 1, 2004. This year these you need to know: DROP accounts will not earn any interest because of the negative actuarial rate. However, DROP accounts are not debited in the event of a negative actuarial rate of return.

Members who were eligible to participate in DROP on or after January 1, 2004, earn interest based on the liquid asset money market rate of return. The average money market rate for 2010 is 0.01 percent.

determines how much interest retiree, it is important that you DROP accounts will earn for report your earnings to TRSL members who were eligible each year to continue receiving to participate in DROP before benefit payments. Here's what

> You should have received a form from TRSL, entitled Statement of Annual Earnings & Disability Receipts so that you may report your income

as required by state law.

- To avoid an interruption of your benefits, TRSL needs to receive the original, notarized form no later than May 1, 2011.
- Nursing home residents are excluded from this reporting requirement; however, a letter from the nursing home certifying residency should be on file with TRSL.
