Name of Fame Awards were presented at the Fall Meeting Banquet. Mrs. Peggy Aime was the honoree from District IV and Mrs. Genevieve Gordon was the honoree from District VIII.

Mrs. Aime began her teaching career in language arts and taught grades 4 through 8 at Gonzales High School, and at Prairieville Middle School in Ascension Parish. She also served as a Language Arts Helping Teacher for the school system. Peggy was then appointed to positions of assistant principal at Prairieville Elementary School and principal at St. Amant Middle School, the position

she was serving in when she retired in 1995.

Two years after retirement, Peggy returned to the business of serving classroom teachers in Louisiana as a trainer and mentor for persons seeking alternative teaching certificates through the Louisiana Resource Center for Educators. She worked with teachers from 1998 through 2008.

LRTA has been an important part of Peggy's retired life activities. She served as unit president of the Ascension Retired Teachers Association for 10 years from 1998 through

2008. She continues to serve as the unit's membership chairperson, a responsibility she accepted in 1997. In addition, Peggy has served as parish legislative member from 1997 to present, and has served on parish committees to rewrite the unit and District IV Constitution and By-laws.

District IV activities have also been an important part of Peggy's retirement years. She served on District IV's Executive Board from 2000 through 2008; she served as president of the district from 2006 to 2008; as district past president from 2008 to 2010; and presently serves as consultant to the district president and as a Legislative Committee member.

State activities include being a lifetime member of LRTA; serving as District IV representative on the LRTA Executive Board; serving as a member of the Benefit Review Committee that led to LRTA's endorsement of AMBA; serving as a member of the committee that created "Vision for the Future" the five year strategic plan for LRTA; serving on LRTA's Constitution and Bylaws Committee; and, serving as chairperson of the LRTA Disaster Assistance Fund for retired educators impacted by Hurricanes Katrina and Rita.

I want to personally thank all of you who expressed your concerns about upcoming changes to health insurance plans offered by the Office of Group Benefits. As a result of your communications with members of your legislative

delegations, the Office of Group Benefits announced on Friday, November 7 that policies and coverage for retirees would remain very much like those currently in place. In order to revert back to these plan provisions, there will be a premium increase, which will probably be implemented July 1, 2015. The actions taken by

the Office of Group Benefits prove what we have said in the past. There is strength in numbers—individually we may not be heard, but collectively we cannot be ignored!

Since the Office of Group Benefits announced intentions to change our insurance coverage plans, LRTA has been doing its best to keep everyone informed about, and updated on, the changes through the LRTA Email Club. It is the quickest and most efficient way to communicate with all of you—the LRTA membership—about news and events that are important to the retired educator community.

Over the years, Peggy has donated quilts and wreaths to the LRTA Foundation for the drawings and silent auctions. In recognition of her generosity, she was selected by the LRTA Foundation as their Leadership Award recipient, which was bestowed upon her at LRTA's 2013 Spring Meeting.

Mrs. Genevieve Gordon was a business education teacher for 13 years in Natchitoches, De Soto, East Baton Rouge, and Sabine Parishes. She then served as principal for nine years at Ebarb School and Zwolle Elementary School. During her time as principal of Zwolle Elementary, the school was one of only two elementary schools in Louisiana to receive the National Distinguished School award in 1997.

Mrs. Gordon was then promoted to the Sabine Parish School Board's

central office staff where she served as both supervisor and assistant superintendent for nine 9 years. She also was on the faculty of Northwestern University in an adjunct professor position for four years.

Ms. Gordon retired in 2006 after 31 years as a professional educator.

She joined LRTA in 2009, and was immediately elected by her peers to serve as District VIII president. She served in that capacity for two terms through 2013. District VIII received the LRTA Cornerstone Award for 3 of the 4 years during her presidency. The Cornerstone Award is bestowed upon the LRTA district which has recruited the highest percentage of members for the calendar year, and the award is presented each year at the LRTA Spring Meeting.

Genevieve still serves LRTA as the president of the Sabine Parish Retired Teachers Association. At our last Spring Meeting, Genevieve

received the Horace G. Robinson Lifetime Membership Award, which is given to the youngest person registered to attend our spring conference.

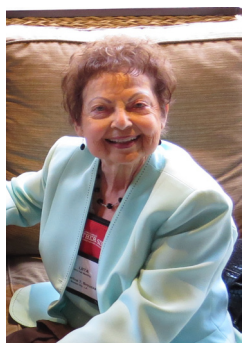

Dr. Merline T. Broussard passed away on October 29, 2014. Dr. Broussard was a dedicated, active and committed educator throughout her life. During her career she served as a classroom teacher at the secondary and post-secondary levels, and retired as director of Administrative Services, Office of Vocational Education in the State Department of Education.

Dr. Broussard served as president of LRTA 2000 - 2002. She previously served as LRTA's first vice-president, president of LRTA District V and president of the Vermilion RTA.

At the time of her death, Dr. Broussard was the state-wide elected representative of retired teachers and school employees on the Office of Group Benefits Policy and Planning Board. She was also an active member of the Bossier Parish Unit and of LRTA District XI.



Jerry J. Boudreaux

Mr. Jerry Boudreaux passed away on November 6, 2014. Mr. Boudreaux was an extraordinary leader and educator. He taught for 39 years, and for 25 of those

years, he was the principal of Zachary High School.

He was the first vice-president of the Baton Rouge Area RTA 2004 - 2005 and was the president 2005 - 2006. Mr. Boudreaux served as LRTA District IV first vice-president 2008 - 2010 and as district president 2010 - 2012. He coordinated LRTA's "Day at the Capitol" in 2009 and in 2010. He was also very active in other organizations around the Baton Rouge area.

Mr. Boudreaux's wife, Cherry Boudreaux, passed away three weeks prior. She was also an LRTA member.

We extend our deepest sympathies to the families of Dr. Broussard and Mr. Boudreaux as we all mourn the loss of two great educators and LRTA leaders.

LRTA Legal Defense Fund

The LRTA Executive Board, during its meeting on October 27, 2014, authorized the establishment of the LRTA Legal Defense Fund. This action was prompted by the situation with OGB and the Division of Administration. It became evident that the Executive Committee, Board, and staff may at times need the benefit of legal expertise in deciding what action to take in protecting our membership. Pat and I planted the seed for this fund by donating \$50 each. Please consider helping. You can make checks payable to LRTA noting that your donation be credited to this fund.

Office of Group Benefits

Retirees were concerned and confused when studying the proposed changes to the Office of Group Benefits health care policies. Much uncertainty exists for an aging population that depends exclusively on a program to provide needed medical care. I am pleased that our concerns were voiced by LRTA members and leadership to those who could calm the fears and make needed changes to the original proposals which would have caused very serious financial and medical consequences. Because of the unified effort of LRTA, elected officials, members of the OGB board, and members of the Governor's staff, changes were made that alleviated a devastating situation for retirees. Beware of Holiday Scams

The holiday season is a busy time of year for everyone. When you are in the holiday spirit you tend to let your guard down, and scammers try to take advantage of that. Here are a few things you can do this holiday season to make sure you aren't the next scam victim.

- Purchase gift cards directly from the stores themselves.
- Stick to stores and websites you know are safe and reputable.
- Only give to charities you know to be reputable.
- Do not click on any links in unsolicited emails, or download any attachments.
- Do not fill out any forms sent by email asking for personal information.
- Use your address bar to enter the direct website address to a business, or banking website, and NEVER follow a link sent by email. Even if the site looks exactly the same, it could be a fake website which looks just like the original, waiting for you to enter your personal information.
- Be aware of these types of scams in text messages also. Scammers are now taking advantage of increased mobile phone usage.
- Also be careful about the information you give out on social networking sites. Scammers can sometimes use this information to hack into your online accounts. They can even use this information to see when you are away from your home, allowing for a break in. Do not trust the blocking features on these sites.
- Beware of non-cyber scams also. Remember the popular caution for both on and offline: If it sounds too good to be true, it probably is.

Just follow these simple suggestions and you will be more apt to have a happy and safe holiday season!

cation of this issue, 6,623 of you have joined the club. The LRTA Email Club has become an especially important tool for us at the LRTA office to utilize during the legislative sessions. We send out a notice each week while the legislature is meeting here in Baton Rouge which describes bills being considered that could impact you as a retired educator, and the actions taken by the legislature on each of those bills.

In the box on Page 8 of this newsletter, located just above Frosty the Snowman, you will find instructions on how to join the LRTA Email Club. We have provided

this information in most recent issues of The Newsletter, but feel it is so important, that we are drawing your attention to it again. It takes but a minute of your time. Follow the easy instructions, and begin receiving all the important news from LRTA.

On another note, I wanted to let all of you know that the Teachers' Retirement System of Louisiana announced some very important information in October. The board of trustees received the Fiscal Year 2013-2014 actuarial valuation at the October meeting. That report revealed TRSL had a market rate of return on investments for the fiscal year of 18.44%.

TRSL Update

Like! How to connect with your loved ones and your retirement with just one click

Here's a set of social media tips from the Teachers' Retirement System of Louisiana. More and more of your friends and family are on Facebook, an online social networking site. Facebook users can keep up with family and friends by sharing photos, videos, and messages.

If you're thinking about signing up, here are a few things to keep in mind.

Profile The first thing you'll do when you sign up for a Facebook account is create a profile. This is where you share a little bit about yourself, such as your name and your picture, so that people can identify you. You can share as much or as little information as you like.

Friends/Friending To connect with people on Facebook, you'll have to either send or accept a "friend request." This tells Facebook that you and another person know each other and want to be able to connect online. Each of your Facebook connections is known as a "friend"—even if the person is your son, boss, or dog!

News feed The first page you see when you log into Facebook is your news feed. It shows status updates, photos, and videos that your "friends" have shared.

Posts To share tidbits of your own life, you'll write a "post." Simply type in your thoughts in the share menu at the top of your homepage or timeline – it's the bar right beneath the words "Update Status." Writing a post will share whatever you've written with the broad audience of your Facebook friends, so anyone can see it.

Messages If you're looking to contact someone privately, you can do so by sending them a message. Click on their name, then at the top of their home page, click "message." A small box will appear on the lower right hand side of the screen- here is where you can type your message, and only this person will see it.

Liking To show that you like a post, photo, comment, or page, you can click "like" on the item. Clicking "like" not only shows how you feel, it also connects your profile to the page or profile of the item you've liked. And, you become more likely to see things from these accounts.

Be careful Don't share highly personal or private information on Facebook. This includes phone numbers, email addresses, home addresses, credit card information, vacation plans, or Social Security numbers. You will need to use an email address to sign up for Facebook, but you won't be asked to use it any further.

Connect with TRSL! You can connect with much more than just your friends and family. You can connect with businesses, organizations, and even your retirement system. That's right, TRSL has a Facebook page! Simply log in to Facebook and type "Teachers' Retirement System of Louisiana" in the top search bar. Click our name and like our page! You'll get updates, teacher humor, and tips.
