## LRTA Takes Steps To Improve Membership

LRTA President Dr. Lonnie Dunn and I have discussed the upcoming courses of action LRTA should take in order to help cultivate our membership initiatives. We have decided that during the coming year, LRTA should concentrate on becoming more involved in processes that impact our membership and our causes. We are proposing that we take steps to better improve our advocacy initiatives. These steps involve three general areas:

- Membership Recruitment,
- Membership Involvement, and
- Growing Membership Strength.

### Membership Recruitment

With the assistance provided last year by Dr. Jesse Scott LRTA's First Vice-President and Dr. John Foster, former LRTA president, LRTA created a model, and a program that can be used for the recruitment of associate members. We intend to continue encouraging the use of that program by LRTA district presidents and their cadre of volunteers to present this program to active educators. The LRTA office can provide any of you with a copy of the model, which provides step-by-step suggestions on how

to create an associate membership recruitment program in your area. We also want to concentrate on improving our continuing efforts of recruiting retired members who have not joined LRTA, and we will be working with the Membership Committee to initiate some new ideas in that regard.

### Membership Involvement

Moving the association forward is going to have to involve the LRTA membership, especially in the area of communication with members of the Louisiana legislature. We are going to implement a series of programs that should facilitate this goal. At the Fall Meeting we will schedule a session to provide information on what units are doing to help members of their legislative delegations become informed about our issues. Information will be provided by the staff, and we have three areas that will be sharing experiences at that session: Caddo Retired Teachers Association, St. Tammany Retired Teachers Association and LRTA District VII. We also need to concentrate on finding legislative contacts for each of the members of the legislature.

## Lonnie's Lagnaipe

I trust that each of you has had a good summer and all your plans you made for trips, home projects, family visits, and other activities were accomplished. Your Executive Board has spent many hours and days planning a course of action for our LRTA to move to better serve the needs and desires of the retired educators in Louisiana. In the next few paragraphs I will outline plans being made and activities already undertaken for all of us to join together to strengthen LRTA, the only organization in Louisiana solely representing retired educators.

As office staff and state-wide officers attend the eleven district meetings, we will bring with us the parish lists of retirees, as verified by TRSL, for each district. The lists are being furnished as a tool for members of the district to actively recruit and enlist new members for LRTA. There are two

categories of retirees that are listed by address but there are no phone numbers or e-mail contacts on these lists. We are going to ask you to keep up with these lists, write accurate contact information on them, and return them to Renee Siccone after our membership drive is complete in April, 2013. The two categories of non-members are (1) those whose membership has lapsed, and (2) those who have never joined. We recognize that this is a huge request that we are making, but once we get the additional contact information we will figure out a method to file it for future use. As you enroll members, make every effort to get them to select payroll deduction which should eliminate the need to solicit membership from them again. We must have more than one-third of retirees as members if LRTA is going to be recognized by our legislature as a viable organization which they must heed as we actively solicit their support to our causes. Mrs. Maria George, First Vice-President and State Membership Chair, is working on the development of new membership recruitment tools and resources. We need your support more than ever before. If you have ideas or suggestions

## Executive Director's Report

On November 6 we will all have the opportunity to vote. We will choose our future national leaders that day, including the members of the U. S. House of Representatives who will represent our interests back home. In addition, you will also be asked to vote on nine amendments to the Louisiana Constitution. LRTA does not endorse or monetarily support candidates for public office, but we do, as an association, take positions on federal and state legislation that affect the membership. Here is a brief summary of the amendments on which you will be asked to vote.

### Amendment No. 1.

This amendment will prohibit money in the Medicaid Trust Fund for the Elderly from being used for other budgeted purposes when adjustments are made to the state operating budget to eliminate a deficit.

### Amendment No. 2.

This amendment provides that the right to keep and bear arms is a fundamental right, and any restriction of that right will require the highest standard of review by the courts.

### Amendment No. 3.

This amendment increases the number of days legislation affecting public employee retirement systems must be filed before the start of any legislative session from 10 days to 45 days.

**Executive Director's Report***Continued from page 2***Amendment No. 4.**

This amendment will allow the spouse of a deceased veteran to retain a special homestead exemption on jointly owned property if the veteran dies before the property exemption was granted.

**Amendment No. 5.**

This amendment will authorize the forfeiture of public retirement benefits of public servants convicted of certain felony crimes related to their public office or position.

**Amendment No. 6.**

This amendment will allow the city of New Iberia to grant property tax exemptions on property annexed by the city after January 1, 2013.

**Amendment No. 7.**

This amendment will allow membership of certain boards coinciding with congressional districts to remain at their present size even when the number of congressional districts is reduced.

**Amendment No. 8.**

This amendment will authorize property tax exemptions for qualified non-manufacturing industries that locate in an area if local authorities approve of granting the exemption.

**Amendment No. 9.**

This amendment will require cities creating special neighborhood anti-crime districts to give proper notice and provide detailed information on legislation that is enacted to create the district.

As you examine the above list, you will note that some of the amendments deal with tax exemptions, some are specific to your local areas, some point to your personal and political beliefs, but there is one to which I would ask you pay particular attention. Amendment No. 3., if passed by the electorate, will allow 35 additional days to review any legislation introduced that affects any public employee retirement system here in Louisiana. This proposal will give all of us who are engaged in the enhancement and protection of our public employee retirement plans additional time to study, digest and comment on potential laws that could impact your livelihood. LRTA supports the passage of Amendment No. 3. Please go vote on November 6, and consider voting "YES" on Amendment No. 3.

Another of our goals for this first year of my presidency is to strengthen local RTA units by, first of all identifying those that need organizational and program planning assistance, and then working with the district presidents to develop strategies to make them stronger. Mrs. Bert Breland, Second Vice-President and State Program Chair, has begun working with LRTA staff and individual district presidents to seek out local RTAs that would like some assistance with developing and organizing meetings and programs, identifying potential officers, and promoting attendance. Contact Mrs. Breland if you desire to get some immediate help with your RTA. We are asking each local RTA to also elect/select a slate of officers that coincides with the State and district officers so that there can

begin to be some officer training in order to find a slate of officers willing to serve each year. If each district and RTA will elect/select a secretary and a treasurer it will give additional retirees opportunities to serve and gain experience. There has been a relaxed attitude in some of our local units that we must overcome if we are going to strengthen our organization.

Mr. Benjamin Sandifer, Chairman of the LRTA Legislative Committee, is already planning contact strategies and procedures for our members to use to get in touch with legislators as the need arises anytime in the future. He is also interested in the building of relationships with our Legislators long before we need their help. We have asked the district presidents to supply a list of volunteers from our membership that would agree to serve as a contact for every senator and representative. It would be advantageous if the volunteer personally knows the individual

legislator, but that is not mandatory. It would also be advantageous for the volunteer to be somewhat proficient in the use of a computer because so many of the communications to be sent to legislators will be via email. We must have those contacts in the LRTA office as expeditiously as possible. We have no idea of legislation that may be introduced this next legislative session, but we do know that we need your assistance to be prepared.

As I stated in the last newsletter, LRTA must have the active support of each member in order to meet the challenges ahead and to strengthen the association to the degree necessary to be recognized as the organization with which to be affiliated as a retired educator. Please join me and your board of directors in working to that end.

## Office of Group Benefits - Update

### Office of Group Benefits announces changes for 2013

As you may know, the Office of Group Benefits recently awarded a contract to Blue Cross and Blue Shield of Louisiana to administer both the PPO plan and the HMO plan for 2013. Blue Cross currently administers the HMO plan.

As a result, beginning January 1, 2013, PPO and HMO plan members will have a single point of contact for both plans, with 8 customer service centers available around the state (compared to 7 now).

PPO plan members also will receive other benefits HMO plan members now have. These include a nationwide provider network and discounts on gym memberships, hearing aids, diet programs and other services.

Because both the PPO plan and the HMO plan will remain self-insured, OGB will continue to determine plan benefits and set premium rates, based on recommendations from actuarial consultants contracted by OGB.

OGB will implement a reorganization plan in early 2013 to streamline the agency's operations and eliminate functions that will no longer be needed. OGB's remaining employees will continue to oversee all OGB health coverage and life insurance, including all self-insured health plans and fully-insured HMO plans and Medicare Advantage HMO plans.

In October, during Annual Enrollment and Medicare Advantage Annual Enrollment, retirees with OGB health plan coverage can choose from various health plan options for the 2013 plan year (January 1 through December 31, 2013).

Retirees who have both Medicare Part A and Part B have even more health plan choices. In addition to the standard plans offered to all retirees, they are also eligible to choose from a variety of Medicare Advantage plan options, some of which are new for 2013.

OGB has selected Extend Health as an approved partner to offer additional Medicare Advantage and Medicare Supplement plan options to OGB plan members who have Medicare Part A and Part B. Extend Health is a marketplace that offers individual Medicare plans from over 80 national and regional companies. Eligible plan members will receive more information from OGB and Extend Health about this new enrollment option.

During October, I encourage all retirees to attend an OGB Annual Enrollment meeting and retirees with Medicare to attend an OGB Medicare Advantage Enrollment meeting to learn more about OGB health plan offerings for 2013.

I hope that you had a HEALTHY and ENJOYABLE summer.
